21	1 heard, and represented by counsel, and instructions on how to apply t	o the
22	2 court for appointment of counsel if indigent, or a uniform notice as	developed
23	3 and prescribed by the Arkansas Supreme Court. The notice of hearing	shall be
24	4 served in the manner provided for service under the Arkansas Rules of	Civil
25	5 Procedure (ARCP)."

27	7 SECTION 2. Arkansas Code Annotated Section 9-27-334(b) is amen	ded to

31	1 or to a relative or other individual.	
32	2 (2) Such order of custody shall supersede an existing court or	der of
33	3 custody and shall remain in full force and effect until a subsequent	order of
34	4 custody is entered by a court of competent jurisdiction."

36	6 SECTION 3. Arkansas Code Annotated Section 9-27-315 is amended	to read

- 1 as follows:
- 2 "§9-27-315. Emergency hearings.
- 3 (a) Following the issuance of an emergency order removing the custody
- 4 of a juvenile from a parent, guardian, or custodian, the court shall, within
- 5 five (5) business days of the issuance of the ex parte order, hold a hearing
- 6 to determine if probable cause to issue the emergency order continues to
- 7 exist.
- 8 (b) The petitioner shall have the burden of proof by a preponderance of
- 9 evidence that probable cause exists for continuation of the emergency order.
- 10 (c) If the court determines that the juvenile can safely be returned to
- 11 his home pending adjudication, the court shall so order.
- 12 (d)(1) At the emergency hearing the court shall set the time and date
- 13 for the adjudication hearing.
- 14 (2) The adjudication hearing shall be held within thirty (30)
- 15 days of the emergency hearing, but may be continued for no more than twenty
- 16 (20) days following the first thirty (30) days on motion of any party for good
- 17 cause shown."

- 19 SECTION 4. Arkansas Code Annotated Sections 9-27-330(5)(6) and (7) are
- 20 amended to read as follows:
- 21 "(5) Assess a court cost of no more than thirty-five dollars (\$35.00)
- 22 to be paid by the juvenile or his parent or guardian.
- 23 (6) Order restitution to be paid by the juvenile or his parent or
- 24 guardian.
- 25 (7) Order a fine of not more than five hundred dollars (\$500) to be paid
- 26 by the juvenile or his parent or guardian."

- 28 SECTION 5. All provisions of this act of a general and permanent nature
- 29 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
- 30 Revision Commission shall incorporate the same in the Code.

- 32 SECTION 6. If any provision of this act or the application thereof to
- 33 any person or circumstance is held invalid, such invalidity shall not affect
- 34 other provisions or applications of the act which can be given effect without
- 35 the invalid provision or application, and to this end the provisions of this
