- 15 SECTION 3. All provisions of this act of a general and permanent nature
- 16 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
- 17 Revision Commission shall incorporate the same in the Code.

- 19 SECTION 4. If any provision of this act or the application thereof to
- 20 any person or circumstance is held invalid, such invalidity shall not affect
- 21 other provisions or applications of the act which can be given effect without
- 22 the invalid provision or application, and to this end the provisions of this
- 23 act are declared to be severable.

- 25 SECTION 5. All laws and parts of laws in conflict with this act are
- 26 hereby repealed.

- 28 SECTION 6. EMERGENCY. It is hereby found and determined by the General
- 29 Assembly that the laws relating to the freedom to select medical providers is
- 30 currently inadequate to assure total freedom in such selection; and that this
- 31 act is designed to correct this situation and should be given effect
- 32 immediately. Therefore, an emergency is hereby declared to exist and this act
- 33 being necessary for the preservation of the public peace, health and safety
- 34 shall be in full force and effect from and after its passage and approval.
