# A Bill

**ACT 663 OF 1993**  
**SENATE BILL 567**

## For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND  
9 OPERATING EXPENSES FOR THE BLACK RIVER TECHNICAL COLLEGE  
10 FOR THE BIENNIAL PERIOD ENDING JUNE 30, 1995; AND FOR  
11 OTHER PURPOSES."

## Subtitle

14 "AN ACT FOR THE BLACK RIVER TECHNICAL COLLEGE  
15 APPROPRIATION."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 SECTION 1. REGULAR SALARIES. There is hereby established for the Black  
20 River Technical College for the 1993-95 biennium, the following maximum number  
21 of regular employees whose salaries shall be governed by the provisions of the  
22 Uniform Classification and Compensation Act (Arkansas Code §§21-5-201 et  
23 seq.), or its successor, and all laws amendatory thereto. Provided, however,  
24 that any position to which a specific maximum annual salary is set out herein  
25 in dollars, shall be exempt from the provisions of said Uniform Classification  
26 and Compensation Act. All persons occupying positions authorized herein are  
27 hereby governed by the provisions of the Regular Salaries Procedures and  
28 Restrictions Act (Arkansas Code §21-5-101), or its successor.

13 SECTION 2. EXTRA HELP. There is hereby authorized, for the Black  
 14 River Technical College for the 1993-95 biennium, the following maximum number  
 15 of part-time or temporary employees, to be known as "Extra Help", payable from  
 16 funds appropriated herein for such purposes: twenty-six (26) temporary or  
 17 part-time employees, when needed, at rates of pay not to exceed those provided  
 18 in the Uniform Classification and Compensation Act, or its successor, or this  
 19 act for the appropriate classification.

20

21 SECTION 3. APPROPRIATIONS. There is hereby appropriated, to the Black  
 22 River Technical College, to be payable from the Black River Technical College  
 23 Fund, for personal services and operating expenses of the Black River  
 24 Technical College for the biennial period ending June 30, 1995, the following:

6 SECTION 4. APPROPRIATIONS - CASH FUNDS. There is hereby appropriated,  
 7 to the Black River Technical College, to be payable from cash funds as defined  
 8 by Arkansas Code 19-4-801 of the Black River Technical College, for personal  
 9 services and operating expenses of the Black River Technical College for the  
 10 biennial period ending June 30, 1995, the following:

31 SECTION 5. PRIORITIES. A high priority of the Black River Technical  
 32 College shall be the combatting of illiteracy and the providing of industrial  
 33 training, in the work place.

34

35 SECTION 6. The appropriation level provided in Section 3 of this Act

1 shall not be construed as a commitment of the Arkansas General Assembly to  
2 provide a particular level of support from the Work Force 2000 Development  
3 Fund for the Black River Technical College but rather that the funds to be  
4 made available are to be based upon legitimate criteria and accreditation  
5 requirements as determined by the State Board of Higher Education for all  
6 technical colleges.

7

8       SECTION 7. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
9 authorized by this Act shall be limited to the appropriation for such agency  
10 and funds made available by law for the support of such appropriations; and  
11 the restrictions of the State Purchasing Law, the General Accounting and  
12 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
13 Procedures and Restrictions Act, the Higher Education Expenditure Restrictions  
14 Act, or their successors, and other fiscal control laws of this State, where  
15 applicable, and regulations promulgated by the Department of Finance and  
16 Administration, as authorized by law, shall be strictly complied with in  
17 disbursement of said funds.

18

19       SECTION 8. LEGISLATIVE INTENT. It is the intent of the General  
20 Assembly that any funds disbursed under the authority of the appropriations  
21 contained in this Act shall be in compliance with the stated reasons for which  
22 this Act was adopted, as evidenced by the Agency Requests, Executive  
23 Recommendations and Legislative Recommendations contained in the budget  
24 manuals prepared by the Department of Finance and Administration, letters, or  
25 summarized oral testimony in the official minutes of the Arkansas Legislative  
26 Council or Joint Budget Committee which relate to its passage and adoption.

27

28       SECTION 9. CODE. All provisions of this Act of a general and permanent  
29 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
30 Code Revision Commission shall incorporate the same in the Code.

31

32       SECTION 10. SEVERABILITY. If any provision of this Act or the  
33 application thereof to any person or circumstance is held invalid, such  
34 invalidity shall not affect other provisions or applications of the Act which  
35 can be given effect without the invalid provision or application, and to this

1 end the provisions of this Act are declared to be severable.

2

3 SECTION 11. GENERAL REPEALER. All laws and parts of laws in conflict  
4 with this Act are hereby repealed.

5

6 SECTION 12. EMERGENCY CLAUSE. It is hereby found and determined by the  
7 Seventy-Ninth General Assembly, that the Constitution of the State of Arkansas  
8 prohibits the appropriation of funds for more than a two (2) year period; that  
9 the effectiveness of this Act on July 1, 1993 is essential to the operation of  
10 the agency for which the appropriations in this Act are provided, and that in  
11 the event of an extension of the Regular Session, the delay in the effective  
12 date of this Act beyond July 1, 1993 could work irreparable harm upon the  
13 proper administration and provision of essential governmental programs.  
14 Therefore, an emergency is hereby declared to exist and this Act being  
15 necessary for the immediate preservation of the public peace, health and  
16 safety shall be in full force and effect from and after July 1, 1993.
