SENATE BILL 266

For An Act To Be Entitled

8 "AN ACT TO AMEND THE AUTHORIZED COMPENSATION PLAN AND TO
9 PROVIDE FOR THE MAXIMUM ANNUAL SALARIES FOR STATE
10 EMPLOYEES; AND FOR OTHER PURPOSES."

Subtitle

13 "AN ACT TO AMEND THE COMPENSATION PLAN"

15 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

17 SECTION 1. Arkansas Code §21-5-209 (e) is hereby amended to read as
18 follows:

19 "(e) The following grades and pay levels shall be the authorized
20 compensation plan, effective July 1, 1993, for the state service for all
21 positions of agencies and institutions covered by this subchapter to which a
22 classification title and salary grade have been assigned, in accordance with
23 this subchapter and the appropriation act of the agency or institution:

16 SECTION 2. Arkansas Code §21-5-211 (b) (1) (A) is hereby amended to read
17 as follows:

18 "(i) (a) The maximum rate of compensation for which an employee shall be
19 eligible on July 1, 1993 shall be the same as the employee's June 30, 1993
20 salary. The employee shall, however, remain eligible for all other merit-
21 based or special compensation provisions provided for by the various sections
22 of this subchapter.

23 (b) The maximum rate of compensation for which an employee shall be
24 eligible on July 1, 1994 shall be determined by increasing the employee's June
25 30, 1994 salary by one percent (1%). Employees whose salary falls below Pay
26 Level I for the grade assigned to their classification may be adjusted to
27 entry level. All other employees shall be adjusted to the appropriate pay
28 level for the grade assigned to their classification, but may not exceed the
29 maximum rate provided for that grade unless otherwise provided for by this
30 section. Salary adjustments provided for in this section shall be made for
31 all employees covered by the provision of this subchapter prior to all other
32 salary adjustments.

33 (ii) When an employee is demoted for cause or voluntarily solicits a
34 demotion, his or her rate of pay shall be fixed in the lower-graded position
35 at a rate equal to six percent (6%) less than the employee's rate of pay at

1 the time of demotion for demotions of one (1) grade and a maximum of eight
2 percent (8%) less than the employee's rate of pay at the time of demotion for
3 demotions of two (2) or more grades."

4

5 SECTION 3. Arkansas Code 21-5-211(b)(3)(B) is hereby amended to read as
6 follows:

7 "(B) When an employee's position has been approved for reclassification
8 to a classification title of a higher salary grade, the employee shall be
9 eligible for an additional two percent (2%) increase in the new
10 classification. An employee, upon reclassification, who is receiving a rate
11 of pay that is less than the entrance rate for the new grade, may be adjusted
12 to the new entrance rate."

13

14 SECTION 4. Arkansas Code 2-5-211(b)(1)(A) is hereby amended to read as
15 follows:

16 "(iii) Employees covered by the provisions of this subchapter shall be
17 eligible during the 1993-95 biennium, for an additional two percent (2%)
18 salary increase provided sufficient general revenues become available.

19 (iv) The line-item maximum annual salary rates for the 1993-95 biennium
20 as set out by law for departments, boards, commissions, institutions of higher
21 education and state agencies enacted by the Seventy-Ninth General Assembly may
22 be increased by an amount not to exceed two percent (2%) provided sufficient
23 general revenues become available, and the resulting salary shall represent
24 the maximum annual salary rate for the 1993-95 biennium."

25

26 SECTION 5. CODE. All provisions of this Act of a general and permanent
27 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
28 Code Revision Commission shall incorporate the same in the Code.

29

30 SECTION 6. SEVERABILITY. If any provision of this Act or the
31 application thereof to any person or circumstance is held invalid, such
32 invalidity shall not affect other provisions or applications of the Act which
33 can be given effect without the invalid provision or application, and to this
34 end the provisions of this Act are declared to be severable.

35

1 SECTION 7. GENERAL REPEALER. All laws and parts of laws in conflict
2 with this Act are hereby repealed.
