24	(a) There is established within each county of this state a county

29	(b) The membership of each cooperation council shall consist of the
30	county judge, the county clerk, the mayor of each city and incorporated town
31	within each county.
32	(1) The county judge of each county shall serve as chairman of
33	the cooperation council. The county judge shall have full voting power and
34	shall have veto power over any action taken by the council. It shall require
35	a two-thirds (2/3) majority vote of all council members to override a veto.

1 of the cooperation council, shall preside over cooperation council meetings in 2 the absence of the council chairman, and shall be responsible for writing and 3 submitting all reports of the cooperation council. (c) Each member of the council shall have one (1) vote for the local 4 5 government jurisdiction they represent on the cooperation council. 6 (d) The members of the cooperation council shall serve without 7 compensation for their services. (e) A quorum shall consist of a majority of the council's membership 8 9 and shall be necessary to conduct its business." 10 11 SECTION 2. All provisions of this act of a general and permanent nature 12 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 13 Revision Commission shall incorporate the same in the Code. 14 15 SECTION 3. If any provision of this act or the application thereof to 16 any person or circumstance is held invalid, such invalidity shall not affect 17 other provisions or applications of the act which can be given effect without 18 the invalid provision or application, and to this end the provisions of this 19 act are declared to be severable. 20 21 SECTION 4.
