SENATE BILL 586

For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND
9 OPERATING EXPENSES FOR THE HEALTH SERVICES AGENCY FOR THE
10 BIENNIAL PERIOD ENDING JUNE 30, 1995; AND FOR OTHER
11 PURPOSES."

Subtitle

14 "AN ACT FOR THE HEALTH SERVICES AGENCY APPROPRIATION."

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18 SECTION 1. REGULAR SALARIES. There is hereby established for the
19 Health Services Agency for the 1993-95 biennium, the following maximum number
20 of regular employees whose salaries shall be governed by the provisions of the
21 Uniform Classification and Compensation Act (Arkansas Code §§21-5-201 et
22 seq.), or its successor, and all laws amendatory thereto. Provided, however,
23 that any position to which a specific maximum annual salary is set out herein
24 in dollars, shall be exempt from the provisions of said Uniform Classification
25 and Compensation Act. All persons occupying positions authorized herein are
26 hereby governed by the provisions of the Regular Salaries Procedures and
27 Restrictions Act (Arkansas Code §21-5-101), or its successor.

21 SECTION 3. REGULAR SALARIES - HEALTH SERVICES AGENCY - DEVELOPMENTAL
22 DISABILITIES PLANNING COUNCIL. There is hereby established for the Health
23 Services Agency - Developmental Disabilities Planning Council for the 1993-95
24 biennium, the following maximum number of regular employees whose salaries
25 shall be governed by the provisions of the Uniform Classification and
26 Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and all
27 laws amendatory thereto. Provided, however, that any position to which a
28 specific maximum annual salary is set out herein in dollars, shall be exempt
29 from the provisions of said Uniform Classification and Compensation Act. All
30 persons occupying positions authorized herein are hereby governed by the
31 provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas
32 Code §21-5-101), or its successor.

33 SECTION 5. APPROPRIATIONS - HEALTH SERVICES AGENCY - DEVELOPMENTAL
 34 DISABILITIES PLANNING COUNCIL - FEDERAL. There is hereby appropriated, to the
 35 Health Services Agency, to be payable from the federal funds as designated by

1 the Chief Fiscal Officer of the State, for personal services and operating
2 expenses and federal grants of the Health Services Agency - Developmental
3 Disabilities Planning Council - Federal for the biennial period ending June
4 30, 1995, the following:

20 *SECTION 6. The Governor may at any time transfer all personnel,*
21 *appropriations, fund balances and authorized positions; and the powers,*
22 *duties, and personnel of the Developmental Disabilities Planning Council to*
23 *any other designated agency of the state which meets the requirements of*
24 *Public Law 101-496.*

25
26 *SECTION 7. CARRY FORWARD. Any unexpended balance of funds generated by*
27 *fees and fines pursuant to Arkansas §Code 20-8-103 et. seq. deposited into the*
28 *State General Services Fund Account which remain at the close of each state*
29 *fiscal year shall be carried forward to the next state fiscal year to be used*
30 *for the sam intent and purposes as set forth in law.*

31
32 *SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds*
33 *authorized by this Act shall be limited to the appropriation for such agency*
34 *and funds made available by law for the support of such appropriations; and*
35 *the restrictions of the State Purchasing Law, the General Accounting and*

1 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
2 Procedures and Restrictions Act, or their successors, and other fiscal control
3 laws of this State, where applicable, and regulations promulgated by the
4 Department of Finance and Administration, as authorized by law, shall be
5 strictly complied with in disbursement of said funds.

6

7 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General
8 Assembly that any funds disbursed under the authority of the appropriations
9 contained in this Act shall be in compliance with the stated reasons for which
10 this Act was adopted, as evidenced by the Agency Requests, Executive
11 Recommendations and Legislative Recommendations contained in the budget
12 manuals prepared by the Department of Finance and Administration, letters, or
13 summarized oral testimony in the official minutes of the Arkansas Legislative
14 Council or Joint Budget Committee which relate to its passage and adoption.

15

16 SECTION 10. CODE. All provisions of this Act of a general and
17 permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the
18 Arkansas Code Revision Commission shall incorporate the same in the Code.

19

20 SECTION 11. SEVERABILITY. If any provision of this Act or the
21 application thereof to any person or circumstance is held invalid, such
22 invalidity shall not affect other provisions or applications of the Act which
23 can be given effect without the invalid provision or application, and to this
24 end the provisions of this Act are declared to be severable.

25

26 SECTION 12. GENERAL REPEALER. All laws and parts of laws in conflict
27 with this Act are hereby repealed.

28

29 SECTION 13. EMERGENCY CLAUSE. It is hereby found and determined by the
30 Seventy-Ninth General Assembly, that the Constitution of the State of Arkansas
31 prohibits the appropriation of funds for more than a two (2) year period; that
32 the effectiveness of this Act on July 1, 1993 is essential to the operation of
33 the agency for which the appropriations in this Act are provided, and that in
34 the event of an extension of the Regular Session, the delay in the effective
35 date of this Act beyond July 1, 1993 could work irreparable harm upon the

1 proper administration and provision of essential governmental programs.
2 Therefore, an emergency is hereby declared to exist and this Act being
3 necessary for the immediate preservation of the public peace, health and
4 safety shall be in full force and effect from and after July 1, 1993.
