24	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25	
26	SECTION 1. Arkansas Code § 14-120-203 is amended to read as follows:
27	"14-120-203. Construction.
28	(a) This subchapter shall be liberally construed and applied to enable
29	levee districts, or drainage districts, or levee and drainage districts to
30	cooperate with the United States of America, or any agents or agency thereof,
31	with respect to the making of contracts or agreements, and the performance of
32	the obligations and requirements thereby imposed, relating to the construction
33	of flood control and drainage works within the boundaries of any such district
34	by the United States of America, which are designed to control the floodwaters
35	of the Mississippi River and its tributaries.
36	(b) Districts located within the Red River basin are empowered to

- 1 cooperate with the United States of America or any agents or agencies thereof,
- 2 with respect to the making of contracts or agreements, and the performance of
- 3 the obligation and requirements thereby imposed, relating to the construction
- 4 and maintenance of levees, revetments, realignments and other flood protection
- 5 works, located outside the boundaries of the district.
- 6 (c) It is the legislative intent that all provisions of this subchapter
- 7 shall be liberally and reasonably construed so as to give them full force and
- 8 effect to the end that the purposes and objectives of this subchapter are
- 9 fully and expeditiously accomplished."

- 11 SECTION 2. Arkansas Code § 14-120-216 is amended to read as follows:
- 12 "14-120-216. Contract authority.
- 13 The board of directors of any levee district, drainage district, or any
- 14 levee and drainage district, in this state is authorized and empowered to make
- 15 and execute any and all necessary and proper contracts with the United States
- 16 Army Corps of Engineers, or any other federal agency, to the end that:
- 17 (1) The district will provide the lands, rights-of-way, and easements
- 18 necessary by purchase, lease, donation, condemnation or otherwise for the
- 19 construction, maintenance, repair, realignment, and/or restoration of the
- 20 works of improvement of any flood control, or drainage project, of the
- 21 Mississippi River and its tributaries which heretofore have been adopted and
- 22 authorized or any such project which may be adopted and authorized by the
- 23 United State of America and the cost thereof paid by the board of directors of
- 24 the district:
- 25 (2) The district will hold and save the United States of America free
- 26 from damages due to the construction of any such flood control and drainage
- 27 works;
- 28 (3) The district will perpetually maintain and operate the flood control
- 29 and drainage works, after completion thereof, in accordance with regulations
- 30 prescribed by the Corps of Engineers or other federal agency; and
- 31 (4) The district will provide any and all additional local assurances
- 32 required of the district by the Corps of Engineers or other federal agency."

- 34 SECTION 3. All provisions of this act of a general and permanent nature
- 35 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code

1 Revision Commission shall incorporate the same in the Code.

         SECTION 4. If any provision of this act or the application thereof to
 4 any person or circumstance is held invalid, such invalidity shall not affect
 5 other provisions or applications of the act which can be given effect without
 6 the invalid provision or application, and to this end the provisions of this
 7 act are declared to be severable.

         SECTION 5. All laws and parts of laws in conflict with this act are
10 hereby repealed.
11
         SECTION 6. EMERGENCY. It is hereby found and determined by the General
12
13 Assembly that the law pertaining to drainage and levee districts should be
14 expanded to authorize the districts within the Red River basin to sponsor
15 construction and maintain, repair, restore, and/or realign levees, revetments,
16 realignments and other associated flood protection improvements and to
17 authorize districts to grant, undertake and carry out assurances of local
18 cooperation and to acquire and make available rights-of-way incident to the
19 prosecution of such works of public improvement which are located outside the
20 boundaries of the districts in order to allow the districts to give assurances
21 to the Corps of Engineers that such improvements will be maintained by the
22 districts; that until such authority is granted, the Corps of Engineers
23 projects located outside a drainage or levee district may be in jeopardy; and
24 that this act should go into effect immediately in order to persuade the Corps
25 of Engineers to continue with revetment projects located outside the
26 boundaries of any levee or drainage district. Therefore, an emergency is
27 hereby declared to exist, and this act being immediately necessary for the
28 preservation of the public peace, health, and safety shall be in full force
29 and effect from and after its passage and approval.
