9 "AN ACT TO AMEND ARKANSAS CODE 27-67-203 TO DESIGNATE
10 PORTIONS OF CERTAIN HIGHWAYS IN RANDOLPH COUNTY AND
11 LAWRENCE COUNTY AS SCENIC HIGHWAYS; AND FOR OTHER
12 PURPOSES."

Subtitle

15 "TO DESIGNATE PORTIONS OF CERTAIN
16 HIGHWAYS IN RANDOLPH AND LAWRENCE
17 COUNTIES AS SCENIC HIGHWAYS."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20

21 SECTION 1. Arkansas Code 27-67-203(a) is amended to read as follows:

22 "(a) The following highways and designated parts of highways within the
23 State of Arkansas are designated as scenic highways:

24 (1) U.S. 65 from the Louisiana line to the Missouri line;

25 (2) U.S. 71 from the Louisiana line to the Missouri line;

26 (3) U.S. 82 from the Mississippi River to Texarkana;

27 (4) U.S. 270 from U.S. 71 to Hot Springs;

28 (5) I-30 from Little Rock to U.S. 70 west of Benton, and U.S. 70 to Hot
29 Springs;

30 (6) I-40 from Little Rock to the Oklahoma line west of Fort Smith;

31 (7) U.S. 63 from I-55 at Turrell to Mammoth Spring;

32 (8) U.S. 62 from the Missouri line to the Oklahoma line;

33 (9) State 7 from the Louisiana line to Bull Shoals Lake north of
34 Harrison;

35 (10) Great River Road State 54 and State 1 from Dumas to Crossroads;
36 route on new location to Wabash, then State 44 through St. Francis National

- 1 Forest to Marianna; U.S. 79 and State 38 and State 147 past Horseshoe Lake
2 back to U.S. 79 and U.S. 70 to West Memphis; U.S. 70 through West Memphis to
3 I-55 and to the Tennessee line; and from the beginning of State 77 and U.S. 70
4 in West Memphis to the Missouri line;
- 5 (11) State 32 and State 355 from Ashdown to Mineral Springs;
- 6 (12) State 27 to Kirby; U.S. 70 and State 8 to Norman; State 27 to
7 Dardanelle; and State 27 from Dover to Harriet;
- 8 (13) State 9 from Crows to Jct. U.S. 65; State 16 from U.S. 65 to
9 Shirley; and State 9 from Shirley to Mammoth Spring;
- 10 (14) State 28 from U.S. 71 to Ola;
- 11 (15) State 154 from Oppelo to State 27;
- 12 (16) State 23 from U.S. 71 to the Missouri line;
- 13 (17) State 309 from State 10 to State 23 at Ozark;
- 14 (18) State 21 from Clarksville to the Missouri line;
- 15 (19) State 16 from Searcy to Siloam Springs, including the connecting
16 segment of State 25 at Heber Springs;
- 17 (20) State 14 from U.S. 63 to Table Rock Lake;
- 18 (21) State 68 from Alpena to Siloam Springs;
- 19 (22) State 5 from U.S. 67 to the Missouri line;
- 20 (23) State 25 from its intersection with U.S. 65 to Heber Springs;
21 State 25 from Heber Springs to Batesville; U.S. 167 from Batesville to Ash
22 Flat; State 286 from its intersection with I-40 to its intersection with State
23 60; State 60 from its intersection with State 286 to Perryville; and State 10
24 from its intersection with State 9 to I-430;
- 25 (24) State 58 from Sage through Guion, and State 69 to Melbourne;
- 26 (25) State 178 from Flippin to Mountain Home;
- 27 (26) State 88 from the Oklahoma line to Mena;
- 28 (27) State 59 from Van Buren to Jct. State 220;
- 29 (28) State 220 from Jct. 59 to State 74 at Devils Den State Park;
- 30 (29) State 170 from Devils Den State Park to U.S. 71 at West Fork;
- 31 (30) I-40 from the Tennessee line to Little Rock;
- 32 (31) I-30 from Benton south to the Clark County line;
- 33 (32) State 10 from Ola to Greenwood;
- 34 (33) State 22 from Dardanelle to Paris;
- 35 (34) State 12 from Rogers to Jct. State 23;
- 36 (35) State 141 from Jonesboro to McDougal;

1 (36) State 125 from its intersection with State 14 north of Yellville
2 to the Missouri line;

3 (37) U.S. 49 from its intersection at Brinkley to the Mississippi state
4 line will be known as the "Delta Parkway, an Arkansas Scenic Highway";

5 (38) State 5 from Benton to Hot Springs;

6 (39) U.S. 64 from its intersection with I-40 in Johnson County westward
7 to the western corporate limits of the city of Ozark;

8 (40) State 186 from its intersection with I-40 in Franklin County south
9 to its intersection with U.S. 64 at Altus;

10 (41) U.S. 70 from its intersection with I-440 in Pulaski County
11 eastward to its intersection with U.S. 49 at Brinkley;

12 (42) U.S. 165 from its intersection with I-440 in Pulaski County
13 eastward to Dumas;

14 (43) State 220 from State 59 to the Oklahoma border; and

15 (44) *That portion of State Highway 166 beginning at its intersection*
16 *with U. S. 62 in Randolph County and extending south to the county line; State*
17 *361 beginning at the Spring River Bridge in Lawrence County and ending at its*
18 *intersection with State 25 in Black Rock; State 25 beginning at its*
19 *intersection with State 361 in Black Rock and ending at the entrance to the*
20 *Lake Charles State Park."*

21

22 SECTION 2. All provisions of this act of a general and permanent nature
23 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
24 Revision Commission shall incorporate the same in the Code.

25

26 SECTION 3. If any provision of this act or the application thereof to
27 any person or circumstance is held invalid, such invalidity shall not affect
28 other provisions or applications of the act which can be given effect without
29 the invalid provision or application, and to this end the provisions of this
30 act are declared to be severable.

31

32 SECTION 4. All laws and parts of laws in conflict with this act are
33 hereby repealed.
