22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. Arkansas Code 16-21-1301 is amended to read as follows:

25 "16-21-1301. Contingent expense allowances.

26 (a) In lieu of any other contingent expense allowance now provided by
27 law for the Prosecuting Attorney of the Eighth Judicial District North and the
28 Prosecuting Attorney of the Eighth Judicial South, the Office of the
29 Prosecuting Attorney of the Eighth Judicial District North and the Office of
30 the Prosecuting Attorney of the Eighth Judicial District South shall receive
31 contingent expense reimbursement funds as provided in this section. The
32 contingent expense reimbursement funds authorized by this section shall be
33 used solely for the purpose of reimbursing the costs of operating the Office
34 of Prosecuting Attorney of the Eighth Judicial District North and the Office
35 of the Prosecuting Attorney of the Eighth Judicial District South.
36 Reimbursements shall be based on itemized documentation, which shall be

1 retained for audit purposes.

2 (b)(1) The respective counties within the Eighth Judicial District North
3 shall contribute annually to the contingent expense fund such amount as shall
4 be approved by the quorum courts of the respective counties within the
5 prescribed minimum and maximum amounts set forth below:

6 Nevada County	Minimum \$1,500
	Maximum 3,500 <u>7,500</u>
8 Hempstead County	Minimum 2,000
	Maximum 5,000 <u>7,500</u>

10 (2) The respective counties within the Eighth Judicial District South
11 shall contribute annually to the contingent expense fund such amount as shall
12 be approved by the quorum courts of the respective counties within the
13 prescribed minimum and maximum amounts set forth below:

14 Lafayette County	Minimum 2,000
	Maximum 5,000 <u>7,500</u>
16 Miller County	Minimum 2,700
	Maximum 5,000 <u>7,500</u>

18 ~~(2)~~(3) The counties in the Eighth Judicial District North and the Eighth
19 Judicial South shall pay the approved allowance in equal monthly
20 installments."

22 SECTION 2. All provisions of this act of a general and permanent nature
23 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
24 Revision Commission shall incorporate the same in the Code.

26 SECTION 3. If any provision of this act or the application thereof to
27 any person or circumstance is held invalid, such invalidity shall not affect
28 other provisions or applications of the act which can be given effect without
29 the invalid provision or application, and to this end the provisions of this
30 act are declared to be severable.

32 SECTION 4. All laws and parts of laws in conflict with this act are
33 hereby repealed.
