15 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

17 SECTION 1. Arkansas Code 14-14-1204 is amended to read as follows:
18 "14-14-1204. Compensation of elected county officers.

19 (a) Authority to Establish Compensation Levels. The quorum court of
20 each county shall, by ordinance, fix the annual salaries of the following
21 county officers within the minimum and maximum provided in this section: The
22 county judge; the sheriff and ex officio collector of taxes; the collector of
23 taxes, where established by law; the circuit clerk; the county clerk, where
24 established by law; the assessor; the treasurer; the coroner; and the
25 surveyor.

26 (b) Classification of Counties. For purposes of determining the
27 salaries of the elected county officers, unless otherwise specifically
28 provided in this section, the counties shall be classified on the basis of
29 population as determined by the preceding federal decennial census according
30 to the following classifications:

4 (c) Judge of the County Court. (1) The annual salary of a county judge
 5 shall be in compensation for his services as the executive and administrator
 6 for the county, as judge of the county court, as judge of the court of common
 7 pleas, where established, as presiding officer of the quorum court, and for
 8 all other services performed as provided by the Arkansas Constitution, by law,
 9 or by county ordinance.

10 (2) The minimum and maximum salaries per annum of the county judge of a
 11 county shall be as follows:

28 (d) Sheriff. (1) The annual salary of a sheriff shall be compensation
 29 for services as a law enforcement officer, as the supervisor of the county
 30 jail, as custodian of persons accused or convicted of crime, as an officer of
 31 the circuit, chancery, or county courts, and as the ex officio county tax
 32 collector and delinquent tax collector in those counties where that office is
 33 combined with the office of sheriff, and for all other services performed as
 34 provided by the Arkansas Constitution, by law, or by county ordinance. In any
 35 county in which the office of sheriff and the office of collector are combined
 36 into a single office, the maximum and minimum salaries of the county shall be

1 one thousand three hundred ninety-two dollars (\$1,392) greater than those
2 prescribed for the appropriate class of county in subdivision (2) of this
3 subsection.

4 (2) The minimum and maximum salaries per annum of the sheriff of a
5 county shall be as follows:

26 as provided by the Arkansas Constitution, by law, or by county ordinance.

27 (2) The minimum and maximum salaries per annum of the county tax
28 collector in those counties where the office has been separated from the
29 office of sheriff shall be as follows:

 13 registrar of voters, and for all other services performed as provided by the
 14 Arkansas Constitution, by law, or by county ordinance. In those counties where
 15 the office of county and probate clerk is combined with the office of circuit
 16 clerk and ex officio recorder, the salary shall be as provided in this
 17 section. In those counties where the office of county and probate clerk is
 18 combined with the office of circuit clerk and ex officio recorder, the minimum
 19 and maximum salaries shall be one thousand three hundred ninety-two dollars
 20 (\$1,392) greater than those prescribed for the appropriate class of county in
 21 subdivision (2) of this subsection.

 23 probate clerk of a county shall be as follows:

 5 clerk and ex officio recorder shall be in compensation for his services as
 6 clerk of the circuit court, as clerk of the chancery court, and as ex officio
 7 recorder, and for all other services performed as provided by the Arkansas
 8 Constitution, by law, or by county ordinance. In those counties where the
 9 office of circuit clerk and ex officio recorder is combined with the office of
 10 county and probate clerk, the minimum and maximum salaries shall be one
 11 thousand three hundred ninety-two dollars (\$1,392) greater than those
 12 prescribed for the appropriate class of county in subdivision (2) of this
 13 subsection.

14 (2) The minimum and maximum salaries per annum of the circuit clerk and
 15 ex officio recorder of a county shall be as follows:

 36 be in compensation for all services performed as county assessor and

1 appraiser, and as provided by the Arkansas Constitution, by law, or by county
 2 ordinance. In any county in which the office of assessor and collector is
 3 combined into a single office, the maximum and minimum salaries of the county
 4 assessor and collector shall be one thousand three hundred ninety-two dollars
 5 (\$1,392) greater than those prescribed for the appropriate class of county in
 6 subdivision (2) of this subsection.

25 (i) County Treasurer. (1) The annual salary of a county treasurer shall
 26 be in compensation for all services performed as provided by the Arkansas
 27 Constitution, by law, or by county ordinance. In any county in which the
 28 office of treasurer and collector is combined into a single office, the
 29 maximum and minimum salaries of the county treasurer and collector shall be
 30 one thousand three hundred ninety-two dollars (\$1,392) greater than those
 31 prescribed for the appropriate class of county in subdivision (2) of this
 32 subsection.

33 (2) The minimum and maximum salaries per annum for the county treasurer
 34 of a county shall be as follows:

 34 SECTION 2. All provisions of this act of a general and permanent nature
 35 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
 36 Revision Commission shall incorporate the same in the Code.

If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the act which can be given effect without the invalid provision or application, and to this end the provisions of this act are declared to be severable.

SECTION 4. All laws and parts of laws in conflict with this act are hereby repealed.
