Arkansas Code 17-102-103 is amended to read as follows: 21 22 "17-102-103. Creation of board - Members - Appointment. (a) There is created the Arkansas State Board of Acupuncture and 23 24 Related Techniques. The board shall consist of three (3) five (5) persons appointed by the Governor as full members and one (1) appointed by the 25 Governor as an ex officio member. Two (2) Three (3) full members of the board 26 shall be qualified acupuncturists. One (1) Two (2) full member members shall 27 28 be appointed to represent the public and shall not have practiced acupuncture 29 and related techniques in this, or any other jurisdiction, nor be retired from or have any financial interest in the occupation regulated. The public member 30 31 members shall be subject to confirmation by the Senate. The public member members shall be a full voting member members but shall not participate in the 32 grading of examinations. The ex officio member shall be a physician licensed 33 pursuant to the Arkansas Medical Practices Act and shall be entitled to be 34 35 notified of all board meetings and to participate in the deliberations of the board, but shall have no vote, shall not serve as an officer of the board, and 36

shall not be counted to establish a quorum or a majority necessary to conduct business.

- (b) The initial full members of the board shall be appointed by the Governor for staggered terms as follows: One (1) member's term shall expire after one (1) year, one (1) shall expire after two (2) years, and one (1) shall expire after three (3) years. Of the two (2) additional members appointed pursuant to the 1999 Act, one (1) shall be appointed for a two (2) year term and the other for a three (3) year term. The initial ex officio board member shall be appointed to a term of three (3) years. Successors shall be appointed for three (3) year terms. Vacancies shall be filled by appointment by the Governor for the unexpired term. Board members shall serve until their successors have been appointed and qualified.
- (c) The Governor may remove any full member from the board for any reason that would justify the suspension or revocation of his license to practice acupuncture and related techniques.
- (d) A person who is, or has been in the preceding two (2) years, on the faculty of a school which is subject to review by the board, may not serve on the board."

SECTION 2. All provisions of this Act of a general and permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code.

SECTION 3. If any provision of this Act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the Act which can be given effect without the invalid provision or application, and to this end the provisions of this Act are declared to be severable.

SECTION 4. All laws and parts of laws in conflict with this Act are hereby repealed.

SECTION 5. <u>EMERGENCY CLAUSE</u>. It is hereby found and determined by the <u>Eighty-second General Assembly that the Board of Acupuncture and related</u> techniques was unable to function during 1998 because a quorum could not be assembled; that this act increases the size of the board so that the quorum
