8 "AN ACT TO ESTABLISH FILING FEES FOR LIMITED LIABILITY  
9 LIMITED PARTNERSHIP; AND FOR OTHER PURPOSES."

### Subtitle

10 "TO ESTABLISH FILING FEES FOR LIMITED  
11 LIABILITY LIMITED PARTNERSHIP."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 SECTION 1. (a) The Secretary of State shall collect the following fees  
20 when the documents described in this subsection are delivered to him for  
21 filing:

23 <u>1. Application for Registration of Limited Liability Limited</u>	
24 <u>Partnership.....</u>	<u>\$50.00</u>

13 9. Application for registration as a Limited Partnership and  
14 Limited Liability Limited Partnership.....50.00

16 10. Any other document required or permitted to be filed by  
17 this chapter.....15.00

19 (b) The Secretary of State shall collect a fee of twenty-five dollars  
20 (\$25.00) each time process is served on her under this act. The party to a  
21 proceeding causing service of process is entitled to recover this fee as costs  
22 if the party prevails in the proceeding.  
23

24 (c) The Secretary of State shall collect the following fees for copying  
25 and certifying the copy of any filed document relating to a domestic or  
26 foreign Limited Liability Limited Partnership:

27 (1) Fifty cents (\$.50) a page for copying; and

28 (2) Five dollars (\$5.00) for the certificate.  
29

30 SECTION 2. All provisions of this act of a general and permanent nature  
31 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
32 Revision Commission shall incorporate the same in the Code.  
33

34 SECTION 3. If any provision of this act or the application thereof to  
35 any person or circumstance is held invalid, such invalidity shall not affect  
36 other provisions or applications of the act which can be given effect without

1 the invalid provision or application, and to this end the provisions of this  
2 act are declared to be severable.

3  
4 SECTION 4. All laws and parts of laws in conflict with this act are  
5 hereby repealed.
