19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code 5-73-209 is repealed.

22 ~~5-73-209. Registration by owners and users.~~

23 ~~(a) Every machine gun now in this state adapted to use pistol-~~
24 ~~cartridges of 30 (.30 in. or 7.63 mm.) or larger caliber shall be registered~~
25 ~~in the office of the Secretary of State.~~

26 ~~(b)(1) Any person acquiring an unregistered machine gun shall register~~
27 ~~the same within twenty four (24) hours after its acquisition.~~

28 ~~(2) A person registering a machine gun with the Secretary of~~
29 ~~State shall not thereafter be required to register or reregister such machine~~
30 ~~gun unless and until there is a change in the name, address, or occupation of~~
31 ~~persons registering the same, in which case the person shall reregister the~~
32 ~~machine gun within twenty four (24) hours after such change.~~

33 ~~(c) Blanks for registration shall be prepared by the Secretary of~~
34 ~~State, and furnished upon application.~~

35 ~~(d) To comply with this section the application as filed must show the~~
36 ~~model and serial number of the gun, the name, address, and occupation of the~~

1 ~~person in possession, and from whom and the purpose for which the gun was~~
2 ~~acquired.~~

3 ~~(e) The registration data shall not be subject to inspection by the~~
4 ~~public.~~

5 ~~(f) Any person failing to register any gun as required by this section~~
6 ~~shall be presumed to possess the gun for offensive or aggressive purpose.~~
