25 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

27 SECTION 1. Arkansas Code 23-67-304(K) (5), concerning the frequency
28 with which the Insurance Commissioner conducts a comprehensive performance
29 review of the plan administrator of Arkansas' Workers' Compensation Insurance
30 Plan, is amended to read as follows:

31 ~~(5)(A) The commissioner shall conduct a performance review on~~
32 ~~the plan administration and each servicing carrier promptly after the end of~~
33 ~~each calendar year.~~

34 ~~(B) This performance review may be conducted by the~~
35 ~~commissioner to the extent deemed necessary for the proper operation of the~~
36 ~~plan.~~

1 (A)(i) The commissioner shall conduct a comprehensive
2 performance review of the plan administrator and each servicing carrier
3 within the first half of the third year of any plan administrator or
4 servicing carrier competitive selection period as often as the commissioner
5 deems advisable, which shall not be less frequent than once every five (5)
6 years to the extent necessary for the proper operation of the plan.

7 (ii) The commissioner shall conduct a performance
8 review of each servicing carrier as often as the commissioner deems advisable
9 in order to assure adequate levels of service.

10 (B) This comprehensive performance review shall be
11 conducted independently of any other performance review conducted by an
12 organization owned or controlled by the insurance carriers.

13 (C) A report of this review and action taken to improve
14 plan performance shall be made to the Legislative Council and the House and
15 Senate Interim Committees on Insurance and Commerce no later than September 1
16 after the calendar year reviewed.
