20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES - ADMINISTRATION / PEST CONTROL. There is
23 hereby established for the State Plant Board for the 2001-2003 biennium, the
24 following maximum number of regular employees whose salaries shall be governed
25 by the provisions of the Uniform Classification and Compensation Act (Arkansas
26 Code §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.
27 Provided, however, that any position to which a specific maximum annual salary
28 is set out herein in dollars, shall be exempt from the provisions of said
29 Uniform Classification and Compensation Act. All persons occupying positions
30 authorized herein are hereby governed by the provisions of the Regular
31 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its
32 successor.

35 SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
36 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER

1 PROVISION - PEST ERADICATION. During either fiscal year of the ~~1999-2001~~
2 2001-2003 Biennium, if the State Plant Board determines that the demands of
3 pest eradication efforts require additional personnel expenses, with the
4 approval of the Chief Fiscal Officer of the State and review by the
5 Legislative Council, appropriations may be transferred from the Pest
6 Eradication Program special line item to the line items for Regular Salaries,
7 Extra Help, Overtime, and Personal Services Matching.

8
9 The provisions of this section shall be in effect only from July 1, 2001
10 through June 30, 2003.

11
12 SECTION 17. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED
13 SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND BALANCES. (A) For all
14 appropriations as provided in this Act, the agency disbursing officer shall
15 monitor the level of fund balances in relation to expenditures on a monthly
16 basis. If any proposed expenditures would cause a fund balance to decline to
17 less than fifty percent (50%) of the balance available on July 1, 2001, the
18 disbursing officer shall immediately notify the executive head of the agency.

19 Prior to any obligations being made under these circumstances, the agency
20 head shall file written documentation with the Chief Fiscal Officer of the
21 State requesting approval of the expenditures. Such documentation shall
22 provide sufficient financial data to justify the expenditures and shall
23 include the following:

- 24 1) a plan that clearly indicates the specific fiscal impact of such
25 expenditures on the fund balance.
- 26 2) information clearly indicating and explaining what programs would be cut or
27 any other measures to be taken by the agency to restore the fund balance.
- 28 3) the extent to which any of the planned expenditures are for one-time costs
29 or one-time purchase of capitalized items.
- 30 4) a statement certifying that the expenditure of fund balances will not
31 jeopardize the financial health of the agency, nor result in a permanent
32 depletion of the fund balance.

33 (B) The Chief Fiscal Officer of the State shall review the request and
34 approve or disapprove all or any part of the request, after having sought
35 prior review by the Legislative Council.

36

1 SECTION 18. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
2 by this act shall be limited to the appropriation for such agency and funds
3 made available by law for the support of such appropriations; and the
4 restrictions of the State Purchasing Law, the General Accounting and Budgetary
5 Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures
6 and Restrictions Act, or their successors, and other fiscal control laws of
7 this State, where applicable, and regulations promulgated by the Department of
8 Finance and Administration, as authorized by law, shall be strictly complied
9 with in disbursement of said funds.

10
11 SECTION 19. LEGISLATIVE INTENT. It is the intent of the General Assembly
12 that any funds disbursed under the authority of the appropriations contained
13 in this act shall be in compliance with the stated reasons for which this act
14 was adopted, as evidenced by the Agency Requests, Executive Recommendations
15 and Legislative Recommendations contained in the budget manuals prepared by
16 the Department of Finance and Administration, letters, or summarized oral
17 testimony in the official minutes of the Arkansas Legislative Council or Joint
18 Budget Committee which relate to its passage and adoption.

19
20 SECTION 20. EMERGENCY CLAUSE. It is found and determined by the General
21 Assembly, that the Constitution of the State of Arkansas prohibits the
22 appropriation of funds for more than a two (2) year period; that the
23 effectiveness of this Act on July 1, 2001 is essential to the operation of the
24 agency for which the appropriations in this Act are provided, and that in the
25 event of an extension of the Regular Session, the delay in the effective date
26 of this Act beyond July 1, 2001 could work irreparable harm upon the proper
27 administration and provision of essential governmental programs. Therefore, an
28 emergency is hereby declared to exist and this Act being necessary for the
29 immediate preservation of the public peace, health and safety shall be in full
30 force and effect from and after July 1, 2001.
