## For An Act To Be Entitled

11 AN ACT TO AMEND ARKANSAS CODE 14-22-101 AND 14-22-106  
12 TO CHANGE THE DEFINITION OF "USED MOTOR VEHICLES,  
13 EQUIPMENT, AND MACHINERY" WHICH ARE EXEMPT FROM THE  
14 SEALED BIDDING PROCEDURES UNDER THE COUNTY GOVERNMENT  
15 PURCHASING LAW; AND FOR OTHER PURPOSES.

## Subtitle

17 TO CHANGE THE DEFINITION OF "USED MOTOR  
18 VEHICLES, EQUIPMENT, AND MACHINERY"  
19 EXEMPTED FROM THE COUNTY GOVERNMENT  
20 PURCHASING LAW.

24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
25

26 SECTION 1. Arkansas Code 14-22-101(8), concerning the definitions for  
27 the law on county government purchasing procedures, is amended to read as  
28 follows:

29 (8) "Used or secondhand motor vehicles, equipment, or machinery" means  
30 any motor vehicles, equipment, or machinery having that is at least two (2)  
31 years in age from the date of original manufacture or that has had at least  
32 five hundred (500) working hours' prior use or ~~eighteen thousand (18,000)~~ ten  
33 thousand (10,000) miles' prior use. Any purchase of used motor vehicles,  
34 equipment, or machinery shall be accompanied by a statement in writing from  
35 the vendor that the motor vehicle, equipment, or machinery is at least two (2)  
36 years in age from the date of original manufacture or has been used a minimum

1 of five hundred (500) hours or driven a minimum of ~~eighteen thousand (18,000)~~  
2 ten thousand (10,000) miles. This statement shall be filed with the county  
3 clerk at the time of purchase.

4  
5 SECTION 2. Arkansas Code 14-22-106(11), concerning the purchases exempt  
6 from sealed bids under the law on county government purchasing procedures, is  
7 amended to read as follows:

8 (11) Used or secondhand motor vehicles, machinery, or equipment, except  
9 that a used or secondhand motor vehicle which has been under lease to a county  
10 when the vehicle had fewer than ~~eighteen thousand (18,000)~~ ten thousand  
11 (10,000) miles of use may not be purchased by the county when it has been used  
12 ~~eighteen thousand (18,000)~~ ten thousand (10,000) miles or more except upon  
13 competitive bids as provided for in this chapter;
