10 AN ACT TO PROVIDE THAT AUTHORITY AND RESPONSIBILITY  
11 UNDER THE PRIVATE CLUB LAW EXTENDS TO THE CLUB'S GOLF  
12 COURSE WHEN HOSTING A PROFESSIONAL GOLF TOURNAMENT  
13 SPONSORED BY A CHARITABLE ORGANIZATION; AND FOR OTHER  
14 PURPOSES.

17 TO PROVIDE THAT AUTHORITY AND  
18 RESPONSIBILITY UNDER THE PRIVATE CLUB  
19 LAW EXTENDS TO THE CLUB'S GOLF COURSE  
20 WHEN HOSTING A PROFESSIONAL GOLF  
21 TOURNAMENT SPONSORED BY A CHARITABLE  
22 ORGANIZATION.

25 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
26

27 SECTION 1. Arkansas Code 3-9-221(b) is amended by adding an additional  
28 subdivision to read as follows:

29 (3)(A) A private club may serve any alcoholic beverage furnished  
30 or drawn under the provisions of subdivision (b)(1) on the golf course on  
31 which the private club is located when the private club is hosting a  
32 professional golf tournament or other charitable golf tournament sponsored by  
33 a charitable organization described in § 501(c)(3) of the federal Internal  
34 Revenue Code and the director has been notified by the private club at least  
35 sixty (60) calendar days prior to the beginning of the event.

36 (B) Persons attending such event shall be deemed guests of

1 the private club and the club may serve the alcoholic beverages to the guests  
2 for cash.

3 (C) The director may promulgate regulations he or she deems  
4 necessary to implement this subsection.
