## For An Act To Be Entitled

10 AN ACT TO AMEND ARKANSAS CODE § 14-42-107 TO  
11 PROHIBIT MUNICIPAL OFFICIALS AND EMPLOYEES FROM  
12 BEING INTERESTED IN CONTRACTS OR SALES TO  
13 MUNICIPALITIES; AND FOR OTHER PURPOSES.

### Subtitle

15 TO PROHIBIT MUNICIPAL OFFICIALS AND  
16 EMPLOYEES FROM SELLING TO  
17 MUNICIPALITIES.

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
22

23 *SECTION 1. Arkansas Code § 14-42-107 is amended to read as follows:*

24 *14-42-107. Interest in offices or contracts, ~~etc., by council members~~*  
25 *prohibited.*

26 *(a)(1) No alderman, ~~or~~ member of any council, or an elected official*  
27 *of a municipal corporation shall, during the term for which he shall have*  
28 *been elected or one (1) year thereafter, be appointed to any municipal office*  
29 *which was created or the emoluments of which shall have been increased during*  
30 *the time for which he shall have been elected.*

31 *(2) No alderman or council member shall be appointed to any*  
32 *municipal office, except in cases provided for in this subtitle, during the*  
33 *time for which he may have been elected.*

34 *(b)(1) No alderman, ~~or~~ council member, official, or municipal employee*  
35 *shall be interested, directly or indirectly, in the profits of any contract*  
36 *for the furnishing of supplies, equipment, or services to the municipality*



1 unless the governing body of the city shall have enacted an ordinance  
 2 specifically permitting aldermen, ~~or~~ council members, officials, or municipal  
 3 employees to conduct business with the city and prescribing the extent of  
 4 this authority.

5 (2) The prohibition prescribed in this subsection shall not  
 6 apply to contracts for the furnishing of supplies, equipment, or services to  
 7 be performed for a municipality by a corporation in which no alderman, ~~or~~  
 8 council member, official, or municipal employee holds any executive or  
 9 managerial office, or by a corporation in which a controlling interest is  
 10 held by stockholders who are not aldermen or council members.
