21 22	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23	SECTION 1. Arkansas Code Title 26, Chapter 35 is amended to add an
24	additional subchapter to read as follows:
25	26-35-1301. Title.
26	This subchapter shall be known and may be cited as the "Military Family
27	Relief Check-off Program".
28	
29	26-35-1302. Contributions.
30	The Revenue Division of the Department of Finance and Administration
31	shall include on the Arkansas individual income tax forms, including those
32	forms on which a husband and wife file separately on the same form, and on
33	all corporate income tax forms, a designation as follows:
34	"(1) If you are entitled to a refund, check if you wish to
35	designate [] \$1, [] \$5, [] \$10, [] \$20, [] \$ (write in

1	amount), or [] all refund due, of your tax refund for the Military Family
2	Relief Check-off Program. Your refund will be reduced by this amount.
3	(2) If you owe an additional amount, check if you wish to

5	\$ (write in amount) for the Military Family Relief Check-off Program.
6	If you wish to make a contribution to the program, you must enclose a
7	separate check for the amount of your contribution, payable to the Military

10	<u>26-35-1303. Administration.</u>
11	(a) The Director of the Department of Finance and Administration may:
12	(1) Accept any gifts, grants, bequests, devises, and donations
13	made to the State of Arkansas for the purpose of funding the Military Family
14	Relief Check-off Program; and
15	(2) Deposit any gifts, grants, bequests, devises, and donations
16	received under this subchapter into the Military Family Relief Trust Fund.
17	(b) The Department of Finance and Administration shall quarterly
18	certify to the Treasurer of State the amount contributed to the Military
19	Family Relief Trust Fund through the state income tax checkoff created under
20	this subchapter, and the Treasurer of State shall deduct from the Individual
21	Income Tax Withholding Fund the amount certified.
22	(c) The Director of the Department of Finance and Administration shall
23	promulgate rules and all income tax forms, returns, and schedules necessary

33	(a) The Adjutant General of the State of Arkansas or his or her
34	designee shall use funds from the Military Family Relief Trust Fund to
35	establish a grant program to assist the families of members of the Arkansas
36	National Guard and Reserves.

1	(b)(1) The grant program created under this subchapter shall assist
2	the families of members of the Arkansas National Guard and Reserves who serve
3	on active duty for a minimum of thirty (30) days as a result of September 11,
4	<u>2001.</u>
5	(2) The eligibility criteria for receiving grants under the
6	grant program shall include, but not be limited to, the following:
7	(A) The need of the family;
8	(B) The pay grade of the member of the Arkansas National
9	Guard and Reserves;
10	(C) The difference between the member's military salary
11	and civilian salary; or
12	(D) Any other factors that establish the family's

15	26-35-1306. Effective dates.
16	(a) The Military Family Relief Check-off Program checkoff on state
17	income tax returns shall be effective for tax years beginning on or after
18	January 1, 2005.
19	(b) The provisions of this subchapter allowing the Director of the
20	Department of Finance and Administration to accept gifts, grants, bequests,
21	devises, and donations shall be effective on August 1, 2005.
22	
23	SECTION 2. Arkansas Code Title 19, Chapter 5, Subchapter 11 is amended
24	to add an additional section to read as follows:
25	<u>19-5-1127. Military Family Relief Trust Fund.</u>
26	(a) There is created on the books of the Treasurer of State, the
27	Auditor of State, and the Chief Fiscal Officer of the State a trust fund to
28	be known as the "Military Family Relief Trust Fund".
29	(b)(1) All moneys collected under §§ 26-35-1302 and 26-35-1303 shall
30	be deposited into the State Treasury to the credit of the fund.
31	(2) The fund shall also consist of any other revenues as may be
32	authorized by law.
33	(c) The fund shall be used exclusively by the Adjutant General or his
34	or her designee to assist the families of members of the Arkansas National
35	Guard and Reserves who serve on active duty for a minimum of thirty (30) days
36	as a result of September 11, 2001.

1	(d) The Treasurer of State shall credit to the fund the amount
2	certified each quarter in accordance with § 26-35-1303.
3	(e)(1) The moneys credited to the fund shall be held as trust funds in
4	interest-bearing accounts only.
5	(2) All interest earned shall be credited to the fund and shall
6	be used only for the purposes of the fund.
7	(f) All moneys deposited into the fund, all interest earned on
8	deposits, and the fund balance in the fund may be disbursed as appropriated
9	in each fiscal year of the biennium for the Military Family Relief Check-off
10	Program.
