6	to cover the cost of the initial order of each newly designed license plate.

18	(a) The Department of Finance and Administration shall issue to a
19	vehicle owner an Arkansas Fallen Firefighters' Memorial license plate which
20	shall bear the approved design upon payment of the fee required by law for
21	the registration of the vehicle, payment of five dollars (\$5.00) to cover the
22	design-use contribution, and payment of an additional handling and
23	administrative fee of ten dollars (\$10.00) for the issuance of the special
24	Arkansas Fallen Firefighters' Memorial license plate.
25	(b)(1) The handling and administrative fee of ten dollars (\$10.00)
26	shall only be collected for the first year the special license plates are
27	issued, shall be deposited to the State Central Services Fund for the benefit

19	Except as specifically provided otherwise in this subchapter, the
20	Arkansas Fallen Firefighters' Memorial special license plates shall comply
21	with all other state motor vehicle laws relating to registration and
22	licensing of motor vehicles, including the minimum number of license plate
23	applications required under § 27-15-4004.
