10 AN ACT TO ALLOW THE ARKANSAS FIRE AND POLICE
11 PENSION REVIEW BOARD TO MEET IN EXECUTIVE SESSION
12 WITH THE ARKANSAS LOCAL POLICE AND FIRE
13 RETIREMENT SYSTEM BOARD; TO ALLOW RECORDS
14 CONCERNING THE EXECUTIVE DIRECTOR THAT ARE
15 CREATED BY THE BOARD TO BE CONSIDERED PERSONNEL
16 RECORDS OR JOB EVALUATION OR PERFORMANCE RECORDS;
17 AND FOR OTHER PURPOSES.

19 AN ACT TO ALLOW THE FIRE AND POLICE
20 PENSION REVIEW BOARD TO MEET IN
21 EXECUTIVE SESSION WITH THE LOCAL POLICE

28 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
29

30 SECTION 1. Arkansas Code § 24-11-203(h), concerning the Arkansas Fire
31 and Police Pension Review Board, is amended as follows:

32 (h)(1) The executive director and staff of the Arkansas Local Police
33 and Fire Retirement System shall serve as executive director and staff for
34 the board.

35 (2)(A) The Arkansas Fire and Police Pension Review Board or its



1 designated members may meet in executive session with the Arkansas Local
2 Police and Fire Retirement System Board or its designated members for the
3 purposes stated in and subject to the provisions of § 25-19-106(c) concerning
4 the boards' executive director, staff, or persons being considered for any of
5 those positions.

6 (B)(i) When applicable, records created by or at the
7 instruction of the Arkansas Fire and Police Pension Review Board concerning
8 the boards' executive director or staff shall be considered personnel
9 records, or job evaluation or performance records for purposes of and subject
10 to the provisions of §§ 25-19-105(b)(12) and 25-19-105(c).

11 (ii) The records in subdivision (h)(2)(B)(i) of this
12 section may be made available to the Arkansas Fire and Police Pension Review
13 Board or its designated members and the Boards' executive director.
