9 AN ACT TO MAKE AN APPROPRIATION FOR ONE PERCENT
10 TO PREVENT FOR THE STATE CHILD ABUSE AND NEGLECT

14 AN ACT FOR THE STATE CHILD ABUSE AND
15 NEGLECT PREVENTION BOARD - ONE PERCENT
16 TO PREVENT APPROPRIATION.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. APPROPRIATION - ONE PERCENT TO PREVENT. There is hereby
23 appropriated, to the State Child Abuse and Neglect Prevention Board, to be
24 payable from the *General Improvement Fund or its successor fund or fund*
25 *accounts*, for providing services to the children of incarcerated parents, the
26 caregivers of those children and to the incarcerated parents themselves
27 through the One Percent to Prevent Program of the State Child Abuse and
28 Neglect Prevention Board, the sum of\$200,000.
29

30 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
31 by this act shall be limited to the appropriation for such agency and funds
32 made available by law for the support of such appropriations; and the
33 restrictions of the State Procurement Law, the General Accounting and
34 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
35 Procedures and Restrictions Act, or their successors, and other fiscal



1 control laws of this State, where applicable, and regulations promulgated by
2 the Department of Finance and Administration, as authorized by law, shall be
3 strictly complied with in disbursement of said funds.

4
5 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly
6 that any funds disbursed under the authority of the appropriations contained
7 in this act shall be in compliance with the stated reasons for which this act
8 was adopted, as evidenced by the Agency Requests, Executive Recommendations
9 and Legislative Recommendations contained in the budget manuals prepared by
10 the Department of Finance and Administration, letters, or summarized oral
11 testimony in the official minutes of the Arkansas Legislative Council or
12 Joint Budget Committee which relate to its passage and adoption.

13
14 SECTION 4 EMERGENCY CLAUSE. It is found and determined by the General
15 Assembly, that the Constitution of the State of Arkansas prohibits the
16 appropriation of funds for more than a two (2) year period; that the
17 effectiveness of this Act on July 1, 2005 is essential to the operation of
18 the agency for which the appropriations in this Act are provided, and that in
19 the event of an extension of the Regular Session, the delay in the effective
20 date of this Act beyond July 1, 2005 could work irreparable harm upon the
21 proper administration and provision of essential governmental programs.
22 Therefore, an emergency is hereby declared to exist and this Act being
23 necessary for the immediate preservation of the public peace, health and
24 safety be in full force and effect from and after July 1, 2005.
