## For An Act To Be Entitled

9 AN ACT TO REPEAL THE ALLOWANCE FOR A RESTRICTED  
10 COMMERCIAL DRIVER LICENSE FOR SCHOOL BUS DRIVERS  
11 IN ORDER TO CONFORM THE ARKANSAS REQUIREMENTS FOR  
12 ISSUANCE OF COMMERCIAL DRIVER LICENSES TO FEDERAL  
13 STANDARDS; AND FOR OTHER PURPOSES.

## Subtitle

15 TO CONFORM THE ISSUANCE OF COMMERCIAL  
16 DRIVER LICENSES TO FEDERAL STANDARDS.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. Arkansas Code § 27-23-110(a)(11), concerning the  
23 application for a commercial driver license, is amended to read as follows:

24 (11) Any other information required by the Office of Driver  
25 Services of the Department of Finance and Administration. The application  
26 must be accompanied by an application fee of forty-one dollars (\$41.00). ~~The~~  
27 ~~application fee shall not be required from a person who requests that the~~  
28 ~~license be restricted to the driving of a school bus; provided, however, that~~  
29 ~~such person shall be required to pay the noncommercial driver license fee.~~  
30

31 SECTION 2. Arkansas Code § 27-23-111(b)(3), concerning commercial  
32 driver license endorsements and restrictions, is amended to read as follows:

33 (3) Endorsements and restrictions are:  
34 "H" - authorizes the driver to drive a vehicle transporting  
35 hazardous materials;



1 "K" - restricts the driver to vehicles not equipped with  
2 airbrakes;

3 "T" - authorizes driving double and triple trailers;

4 "P" - authorizes driving vehicles carrying passengers or  
5 carrying passengers for hire;

6 "N" - authorizes driving tank vehicles;

7 "X" - represents a combination of hazardous materials and  
8 tank vehicle endorsements;

9 "M" - authorizes the driver to drive a motorcycle; and

10 "S" - ~~restricts the driver to school buses, church buses,~~  
11 ~~nonprofit day care center buses, buses operated by public transit systems~~  
12 ~~eligible to receive federal and state assistance under programs administered~~  
13 ~~through the Arkansas State Highway and Transportation Department or the~~  
14 ~~United States Department of Transportation, and Class "D" vehicles~~ authorizes  
15 the driver to operate a school bus.
