19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
20

21 SECTION 1. Arkansas Code Title 18, Chapter 16, Subchapter 1 is amended  
22 to add a new section to read as follows:

23 18-16-113. Hunting and fishing rights – Leased farmland.

24 (a)(1) A tenant of leased or rented farmland shall have no right to  
25 hunt or fish or grant the right to hunt or fish on the farmland that he or  
26 she leases or rents unless the right to hunt or fish or to grant the right to  
27 hunt or fish is expressly granted in writing by the owner of the farmland.

28 (2) The right to hunt or fish or to grant the right to hunt or  
29 fish on farmland shall reside solely with the owner of the farmland.

30 (b) The farmland owner's right to hunt or fish on his or her farmland  
31 includes without limitation the right to:

32 (1) Travel by foot or by any type of vehicle or boat, and by any  
33 means on, over, across, and through the farmland, and by any roads,  
34 waterways, ditches, levies, rights of way, or easements on or appurtenant to  
35 the farmland;

36 (2) Move, remove, use, pump, or impound water on, upon, and



1 about the farmland;

2 (3) Erect, maintain, and operate permanent or temporary  
3 structures, facilities, utilities, pumping systems, blinds, docks, decks, and  
4 other similar structures and facilities on the farmland; and

5 (4) Grant other persons, natural or artificial, the right,  
6 concurrently or exclusively, to engage in and undertake any manner or means  
7 of hunting or fishing on, upon, and about the farmland that is leased or  
8 rented, whether orally or in writing, and to exercise any and all of the  
9 foregoing rights attendant thereto.
