20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

SECTION 1. REGULAR SALARIES - PUBLIC EMPLOYEES RETIREMENT SYSTEM.

22 There is hereby established for the Arkansas Public Employees Retirement
23 System for the 2012-2013 fiscal year, the following maximum number of regular
24 employees.

22 SECTION 2. EXTRA HELP - PUBLIC EMPLOYEES RETIREMENT SYSTEM. There is
 23 hereby authorized, for the Arkansas Public Employees Retirement System for
 24 the 2012-2013 fiscal year, the following maximum number of part-time or
 25 temporary employees, to be known as "Extra Help", payable from funds
 26 appropriated herein for such purposes: six (6) temporary or part-time
 27 employees, when needed, at rates of pay not to exceed those provided in the
 28 Uniform Classification and Compensation Act, or its successor, or this act
 29 for the appropriate classification.

30

31 SECTION 3. APPROPRIATION - PUBLIC EMPLOYEES RETIREMENT OPERATIONS.
 32 There is hereby appropriated, to the Arkansas Public Employees Retirement
 33 System, to be payable from the Arkansas Public Employees' Retirement System
 34 Fund, for personal services and operating expenses of the Arkansas Public
 35 Employees Retirement System for the fiscal year ending June 30, 2013, the
 36 following:

 5 appropriated, to the Arkansas Public Employees Retirement System, to be
 6 payable from cash funds as defined by Arkansas Code 19-4-801 of the Arkansas
 7 Public Employees Retirement System, for payment to beneficiaries of the
 8 Judicial Retirement System by check or wired transfer by the Arkansas Public
 9 Employees Retirement System for the fiscal year ending June 30, 2013, the
 10 following:

 16 SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 17 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. JUDICIAL
 18 RETIREMENT FUND TRANSFERS. A sum not to exceed ~~\$29,279~~ \$30,157 in the ~~2011-~~
 19 ~~2012~~ 2012-2013 fiscal year may be transferred from the Judges Retirement Fund
 20 to the Arkansas Public Employees Retirement System Fund for costs incurred by
 21 the Arkansas Public Employees Retirement System in administering the Judicial
 22 Retirement System. Such transfer request shall be made to the Chief Fiscal
 23 Officer of the State, and upon his approval, said transfer shall be made on
 24 his books and those of the Treasurer of the State and the Auditor of the
 25 State.

26 The provisions of this section shall be in effect only from July 1, ~~2011~~
 27 2012 through June 30, ~~2012~~ 2013.

 29 SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 30 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. STATE
 31 POLICE RETIREMENT FUND TRANSFERS. A sum not to exceed ~~\$48,697~~ \$50,158 in the
 32 ~~2011-2012~~ 2012-2013 fiscal year may be transferred from the State Police
 33 Retirement Fund to the Arkansas Public Employees Retirement System Fund for
 34 costs incurred by the Arkansas Public Employees Retirement System in
 35 administering the State Police Retirement System. Such transfer request
 36 shall be made to the Chief Fiscal Officer of the State, and upon his

1 approval, said transfer shall be made on his books and those of the Treasurer
2 of the State and the Auditor of the State.

3 The provisions of this section shall be in effect only from July 1,
4 ~~2011~~ 2012 through June 30, ~~2012~~ 2013.

5
6 SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
7 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXEMPTION
8 FROM PRIOR REVIEW. The Arkansas Public Employees Retirement System is hereby
9 exempted from seeking prior review by the Arkansas Legislative Council with
10 regard to transfers between the Benefits line item in the Cash Fund
11 Appropriation and the Benefits-Non-Employee line item in the Operations
12 Appropriation which are specifically related to transfers necessitated by the
13 changes in retirees' selection of the method of payment of retirement
14 benefits. All other provisions of Arkansas Code §19-4-522 shall be
15 applicable.

16 The provisions of this section shall be in effect only from July 1, ~~2011~~
17 2012 through June 30, ~~2012~~ 2013.

18
19 SECTION 12. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
20 authorized by this act shall be limited to the appropriation for such agency
21 and funds made available by law for the support of such appropriations; and
22 the restrictions of the State Procurement Law, the General Accounting and
23 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
24 Procedures and Restrictions Act, or their successors, and other fiscal
25 control laws of this State, where applicable, and regulations promulgated by
26 the Department of Finance and Administration, as authorized by law, shall be
27 strictly complied with in disbursement of said funds.

28
29 SECTION 13. LEGISLATIVE INTENT. It is the intent of the General
30 Assembly that any funds disbursed under the authority of the appropriations
31 contained in this act shall be in compliance with the stated reasons for
32 which this act was adopted, as evidenced by the Agency Requests, Executive
33 Recommendations and Legislative Recommendations contained in the budget
34 manuals prepared by the Department of Finance and Administration, letters, or
35 summarized oral testimony in the official minutes of the Arkansas Legislative
36 Council or Joint Budget Committee which relate to its passage and adoption.

1
2 SECTION 14. EMERGENCY CLAUSE. It is found and determined by the
3 General Assembly, that the Constitution of the State of Arkansas prohibits
4 the appropriation of funds for more than a one (1) year period; that the
5 effectiveness of this Act on July 1, 2012 is essential to the operation of
6 the agency for which the appropriations in this Act are provided, and that in
7 the event of an extension of the legislative session, the delay in the
8 effective date of this Act beyond July 1, 2012 could work irreparable harm
9 upon the proper administration and provision of essential governmental
10 programs. Therefore, an emergency is hereby declared to exist and this Act
11 being necessary for the immediate preservation of the public peace, health
12 and safety shall be in full force and effect from and after July 1, 2012.
