20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES. There is hereby established for the War
23 Memorial Stadium Commission for the 2014-2015 fiscal year, the following
24 maximum number of regular employees.

3 SECTION 2. EXTRA HELP. There is hereby authorized, for the War
 4 Memorial Stadium Commission for the 2014-2015 fiscal year, the following
 5 maximum number of part-time or temporary employees, to be known as "Extra
 6 Help", payable from funds appropriated herein for such purposes: one hundred
 7 fifty (150) temporary or part-time employees, when needed, at rates of pay
 8 not to exceed those provided in the Uniform Classification and Compensation
 9 Act, or its successor, or this act for the appropriate classification.

10

11 SECTION 3. APPROPRIATION - STATE OPERATIONS. There is hereby
 12 appropriated, to the War Memorial Stadium Commission, to be payable from the
 13 Miscellaneous Agencies Fund Account, for personal services, operating
 14 expenses, major maintenance, renovation of facilities and scoreboards, and
 15 repairs of the War Memorial Stadium Commission - State Operations for the
 16 fiscal year ending June 30, 2015, the following:

32 SECTION 4. APPROPRIATION - CASH OPERATIONS. There is hereby
 33 appropriated, to the War Memorial Stadium Commission, to be payable from cash
 34 funds as defined by Arkansas Code 19-4-801 of the War Memorial Stadium
 35 Commission, for personal services and operating expenses of the War Memorial
 36 Stadium Commission - Cash Operations for the fiscal year ending June 30,

20 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 21 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

22 APPROPRIATION RESTRICTIONS - LAND ACQUISITION. In no event shall any funds
 23 appropriated to the War Memorial Stadium Commission be used for the
 24 acquisition of real estate without the prior review and approval of the
 25 Arkansas Legislative Council or Joint Budget Committee.

26 Determining the maximum number of employees and the maximum amount of
 27 appropriation and general revenue funding for a state agency each fiscal year
 28 is the function of the General Assembly. This is usually accomplished by
 29 delineating such maximums as the appropriation in the appropriation act(s)
 30 for a state agency and the general revenue allocations authorized for each
 31 fund and fund account by amendment to the Revenue Stabilization law.
 32 Therefore, it is both necessary and appropriate that the General Assembly
 33 maintain oversight by requiring prior approval of the Legislative Council or
 34 Joint Budget Committee as provided by this section. The requirement of
 35 approval by the Legislative Council or Joint Budget Committee is not a
 36 severable part of this section. If the requirement of approval by the

1 Legislative Council or Joint Budget Committee is ruled unconstitutional by a
2 court of competent jurisdiction, then the authority of the Commission to
3 acquire real estate is void.

4 The provisions of this section shall be in effect only from July 1, ~~2013~~
5 2014 through June 30, ~~2014~~ 2015.

6
7 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
8 authorized by this act shall be limited to the appropriation for such agency
9 and funds made available by law for the support of such appropriations; and
10 the restrictions of the State Procurement Law, the General Accounting and
11 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
12 Procedures and Restrictions Act, or their successors, and other fiscal
13 control laws of this State, where applicable, and regulations promulgated by
14 the Department of Finance and Administration, as authorized by law, shall be
15 strictly complied with in disbursement of said funds.

16
17 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General
18 Assembly that any funds disbursed under the authority of the appropriations
19 contained in this act shall be in compliance with the stated reasons for
20 which this act was adopted, as evidenced by the Agency Requests, Executive
21 Recommendations and Legislative Recommendations contained in the budget
22 manuals prepared by the Department of Finance and Administration, letters, or
23 summarized oral testimony in the official minutes of the Arkansas Legislative
24 Council or Joint Budget Committee which relate to its passage and adoption.

26 SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General
27 Assembly, that the Constitution of the State of Arkansas prohibits the
28 appropriation of funds for more than a one (1) year period; that the
29 effectiveness of this Act on July 1, 2014 is essential to the operation of
30 the agency for which the appropriations in this Act are provided, and that in
31 the event of an extension of the legislative session, the delay in the
32 effective date of this Act beyond July 1, 2014 could work irreparable harm
33 upon the proper administration and provision of essential governmental
34 programs. Therefore, an emergency is hereby declared to exist and this Act
35 being necessary for the immediate preservation of the public peace, health
36 and safety shall be in full force and effect from and after July 1, 2014.
