22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. REGULAR SALARIES. There is hereby established for the  
25 Department of Finance and Administration - Office of Child Support  
26 Enforcement for the 2014-2015 fiscal year, the following maximum number of  
27 regular employees.

33 SECTION 2. EXTRA HELP. There is hereby authorized, for the Department  
34 of Finance and Administration - Office of Child Support Enforcement for the  
35 2014-2015 fiscal year, the following maximum number of part-time or temporary  
36 employees, to be known as "Extra Help", payable from funds appropriated

1 herein for such purposes: fifteen (15) temporary or part-time employees,  
 2 when needed, at rates of pay not to exceed those provided in the Uniform  
 3 Classification and Compensation Act, or its successor, or this act for the  
 4 appropriate classification.

 6 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,  
 7 to the Department of Finance and Administration - Office of Child Support  
 8 Enforcement, to be payable from the Child Support Enforcement Fund, for  
 9 personal services and operating expenses of the Department of Finance and  
 10 Administration - Office of Child Support Enforcement - Operations for the  
 11 fiscal year ending June 30, 2015, the following:

 27 SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 28 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA  
 29 HELP EXEMPTION. Extra Help positions authorized herein are specifically  
 30 exempt from limitation of hours, either by act or regulation. Provided,  
 31 however, when a temporary or part-time employee is employed by the Department  
 32 of Finance and Administration - Office of Child Support Enforcement for a  
 33 period of time exceeding seven (7) months, a report of such shall be filed  
 34 with the Legislative Council.

35 The provisions of this section shall be in effect only from July 1, ~~2013~~  
 36 2014 through June 30, ~~2014~~ 2015.

SECTION 5. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 6. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 7. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2014 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2014 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2014.
