## For An Act To Be Entitled

8 AN ACT TO MAKE AN APPROPRIATION FOR OPERATING  
9 EXPENSES FOR THE DEPARTMENT OF FINANCE AND  
10 ADMINISTRATION - MANAGEMENT SERVICES DIVISION WHICH  
11 SHALL BE SUPPLEMENTAL AND IN ADDITION TO THOSE FUNDS  
12 APPROPRIATED BY ACT 1374 OF 2013; AND FOR OTHER  
13 PURPOSES.

## Subtitle

16 AN ACT FOR THE DEPARTMENT OF FINANCE AND  
17 ADMINISTRATION - MANAGEMENT SERVICES  
18 DIVISION SUPPLEMENTAL APPROPRIATION.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. APPROPRIATION - EMPLOYEE BENEFITS DIVISION. There is hereby  
25 appropriated, to the Department of Finance and Administration - Management  
26 Services Division, to be payable from the State Central Services Fund, for  
27 operating expenses of the Department of Finance and Administration -  
28 Management Services Division - Employee Benefits Division which shall be  
29 supplemental and in addition to those funds appropriated in Section 13 of Act  
30 1374 of 2013, the following:

6 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds

7 authorized by this act shall be limited to the appropriation for such agency

8 and funds made available by law for the support of such appropriations; and

9 the restrictions of the State Procurement Law, the General Accounting and

10 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary

11 Procedures and Restrictions Act, or their successors, and other fiscal

12 control laws of this State, where applicable, and regulations promulgated by

13 the Department of Finance and Administration, as authorized by law, shall be

14 strictly complied with in disbursement of said funds.

15

16 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General

17 Assembly that any funds disbursed under the authority of the appropriations

18 contained in this act shall be in compliance with the stated reasons for

19 which this act was adopted, as evidenced by the Agency Requests, Executive

20 Recommendations and Legislative Recommendations contained in the budget

21 manuals prepared by the Department of Finance and Administration, letters, or

22 summarized oral testimony in the official minutes of the Arkansas Legislative

23 Council or Joint Budget Committee which relate to its passage and adoption.

25 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General

26 Assembly, that funds provided by the General Assembly for the operations of

27 the Department of Finance and Administration - Management Services Division

28 are, due to unforeseen circumstances, insufficient for the Department of

29 Finance and Administration - Management Services Division to continue to

30 provide essential governmental services; that the provisions of this act will

31 provide the necessary monies for the Department of Finance and Administration

32 - Management Services Division to continue such services; and that a delay in

33 the effective date of this Act could work irreparable harm upon the proper

34 administration and provision of essential governmental programs. Therefore,

35 an emergency is hereby declared to exist and this Act being necessary for the

36 immediate preservation of the public peace, health and safety shall be in

1 full force and effect from and after the date of its passage and approval.

2 If the bill is neither approved nor vetoed by the Governor, it shall  
3 become effective on the expiration of the period of time during which the  
4 Governor may veto the bill. If the bill is vetoed by the Governor and the  
5 veto is overridden, it shall become effective on the date the last house  
6 overrides the veto.
