8 AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES  
9 AND OPERATING EXPENSES FOR THE DEPARTMENT OF FINANCE  
10 AND ADMINISTRATION - DIVISION OF RACING FOR THE  
11 FISCAL YEAR ENDING JUNE 30, 2015; AND FOR OTHER  
12 PURPOSES.

16 AN ACT FOR THE DEPARTMENT OF FINANCE AND  
17 ADMINISTRATION - DIVISION OF RACING  
18 APPROPRIATION FOR THE 2014-2015 FISCAL  
19 YEAR.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. REGULAR SALARIES. There is hereby established for the  
25 Department of Finance and Administration - Division of Racing for the 2014-  
26 2015 fiscal year, the following maximum number of regular employees.

7 SECTION 2. EXTRA HELP. There is hereby authorized, for the Department  
8 of Finance and Administration - Division of Racing for the 2014-2015 fiscal  
9 year, the following maximum number of part-time or temporary employees, to be  
10 known as "Extra Help", payable from funds appropriated herein for such  
11 purposes: twenty-seven (27) temporary or part-time employees, when needed,  
12 at rates of pay not to exceed those provided in the Uniform Classification  
13 and Compensation Act, or its successor, or this act for the appropriate  
14 classification.

16 SECTION 3. APPROPRIATION. There is hereby appropriated, to the  
17 Department of Finance and Administration - Division of Racing, to be payable  
18 from the Miscellaneous Agencies Fund Account, for personal services and  
19 operating expenses of the Department of Finance and Administration - Division  
20 of Racing for the fiscal year ending June 30, 2015, the following:

36 SECTION 4. APPROPRIATION. There is hereby appropriated, to the

1 Department of Finance and Administration - Division of Racing, to be payable  
 2 from the cash fund deposited in the State Treasury as determined by the Chief  
 3 Fiscal Officer of the State, for operating expenses associated with license  
 4 applications for employees at Oaklawn and Southland Parks of the Department  
 5 of Finance and Administration - Division of Racing for the fiscal year ending  
 6 June 30, 2015, the following:

 19 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 20 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA  
 21 HELP - DOG RACING. There is hereby authorized, for the Department of Finance  
 22 and Administration - Division of Racing - Dog Racing, for the ~~2013-2014~~ 2014-  
 23 2015 fiscal year, the maximum number of ~~five (5)~~ nine (9) part-time or  
 24 temporary employees, to be known as "Extra Help", payable from funds  
 25 appropriated herein for such purposes, such employees shall be authorized to  
 26 work over 1,000 hours per year.

27 The provisions of this section shall be in effect only from July 1, ~~2013~~  
 28 2014 through June 30, ~~2014~~ 2015.

29  
 30 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 31 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. RACING  
 32 PASS RESTRICTIONS. The Director of the Department of Finance and  
 33 Administration shall set a maximum number of racing passes to be printed and  
 34 issued annually and it shall not be less than the number printed in 1990.

35 The provisions of this section shall be in effect only from July 1, ~~2013~~  
 36 2014 through June 30, ~~2014~~ 2015.

SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA HELP - HORSE RACING. There is hereby authorized, for the Department of Finance and Administration - Division of Racing - Horse Racing, for the ~~2013-2014~~ 2014-2015 fiscal year, the maximum number of twenty-two (22) part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes, such employees shall be authorized to work over 1,000 hours per year.

The provisions of this section shall be in effect only from July 1, ~~2013~~ 2014 through June 30, ~~2014~~ 2015.

SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 9. LEGISLATIVE INTENT. It is the intent of the General

1 Assembly that any funds disbursed under the authority of the appropriations  
2 contained in this act shall be in compliance with the stated reasons for  
3 which this act was adopted, as evidenced by the Agency Requests, Executive  
4 Recommendations and Legislative Recommendations contained in the budget  
5 manuals prepared by the Department of Finance and Administration, letters, or  
6 summarized oral testimony in the official minutes of the Arkansas Legislative  
7 Council or Joint Budget Committee which relate to its passage and adoption.  
8

9 SECTION 10. EMERGENCY CLAUSE. It is found and determined by the  
10 General Assembly, that the Constitution of the State of Arkansas prohibits  
11 the appropriation of funds for more than a one (1) year period; that the  
12 effectiveness of this Act on July 1, 2014 is essential to the operation of  
13 the agency for which the appropriations in this Act are provided, and that in  
14 the event of an extension of the legislative session, the delay in the  
15 effective date of this Act beyond July 1, 2014 could work irreparable harm  
16 upon the proper administration and provision of essential governmental  
17 programs. Therefore, an emergency is hereby declared to exist and this Act  
18 being necessary for the immediate preservation of the public peace, health  
19 and safety shall be in full force and effect from and after July 1, 2014.
