## For An Act To Be Entitled

8 AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES  
9 AND OPERATING EXPENSES FOR THE DEPARTMENT OF  
10 CORRECTION WHICH SHALL BE SUPPLEMENTAL AND IN  
11 ADDITION TO THOSE FUNDS APPROPRIATED BY ACT 1207 OF  
12 2013; AND FOR OTHER PURPOSES.

## Subtitle

15 AN ACT FOR THE DEPARTMENT OF CORRECTION -  
16 NORTH CENTRAL UNIT SUPPLEMENTAL  
17 APPROPRIATION.

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
22

23 SECTION 1. REGULAR SALARIES. There is hereby established for the  
24 Department of Correction, for the 2013-2014 fiscal year, the following  
25 maximum number of regular employees which shall be supplemental and in  
26 addition to those positions authorized in Section 1 of Act 1207 of 2013.

36 SECTION 2. APPROPRIATION - INMATE CARE & CUSTODY. There is hereby



1 appropriated, to the Department of Correction, to be payable from the  
 2 Department of Correction Inmate Care and Custody Fund Account, for personal  
 3 services and operating expenses of the Department of Correction - Inmate Care  
 4 & Custody which shall be supplemental and in addition to those funds  
 5 appropriated in Section 3 of Act 1207 of 2013, the following:

 18 SECTION 3. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 19 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING  
 20 TRANSFER. Immediately upon the effective date of this Act, the Chief Fiscal  
 21 Officer of the State shall transfer on his or her books and those of the  
 22 State Treasurer and the Auditor of the State the sum of seven hundred  
 23 nineteen thousand eight hundred seventy three dollars (\$719,873) from the  
 24 unobligated funds in the General Improvement Fund to the Department of  
 25 Correction Inmate Care and Custody Fund Account to provide funds for personal  
 26 services and operating expenses to open additional beds at the Department of  
 27 Correction - North Central Unit.

28  
 29 SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
 30 authorized by this act shall be limited to the appropriation for such agency  
 31 and funds made available by law for the support of such appropriations; and  
 32 the restrictions of the State Procurement Law, the General Accounting and  
 33 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 34 Procedures and Restrictions Act, or their successors, and other fiscal  
 35 control laws of this State, where applicable, and regulations promulgated by  
 36 the Department of Finance and Administration, as authorized by law, shall be

1 strictly complied with in disbursement of said funds.

2  
 3 SECTION 5. LEGISLATIVE INTENT. It is the intent of the General  
 4 Assembly that any funds disbursed under the authority of the appropriations  
 5 contained in this act shall be in compliance with the stated reasons for  
 6 which this act was adopted, as evidenced by the Agency Requests, Executive  
 7 Recommendations and Legislative Recommendations contained in the budget  
 8 manuals prepared by the Department of Finance and Administration, letters, or  
 9 summarized oral testimony in the official minutes of the Arkansas Legislative  
 10 Council or Joint Budget Committee which relate to its passage and adoption.

11  
 12 SECTION 6. EMERGENCY CLAUSE. It is found and determined by the General  
 13 Assembly, that funds provided by the General Assembly for the operations of  
 14 the Department of Correction are, due to unforeseen circumstances,  
 15 insufficient for the Department of Correction to continue to provide  
 16 essential governmental services; that the provisions of this act will provide  
 17 the necessary monies for the Department of Correction to continue such  
 18 services; and that a delay in the effective date of this Act could work  
 19 irreparable harm upon the proper administration and provision of essential  
 20 governmental programs. Therefore, an emergency is hereby declared to exist  
 21 and this Act being necessary for the immediate preservation of the public  
 22 peace, health and safety shall be in full force and effect from and after the  
 23 date of its passage and approval.

24 If the bill is neither approved nor vetoed by the Governor, it shall  
 25 become effective on the expiration of the period of time during which the  
 26 Governor may veto the bill. If the bill is vetoed by the Governor and the  
 27 veto is overridden, it shall become effective on the date the last house  
 28 overrides the veto.
