11 TOWARDS A PRESCRIPTION LIMITATION IN THE ARKANSAS

16 TO CLARIFY AND EXPAND THE PRESCRIPTION  
17 LIMITATIONS IN THE ARKANSAS MEDICAID

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
22

23 SECTION 1. Arkansas Code Title 20, Chapter 77, Subchapter 4, is  
24 amended to add an additional section to read as follows:

25 20-77-406. Prescription limits.

26 (a) The Arkansas Medicaid Program shall allow an adult beneficiary to  
27 have six (6) prescriptions per month.

28 (b) Prescriptions issued under the program shall be renewed at time  
29 intervals consistent with and no stricter than state and federal laws.

30 (c) The program shall not count a medication for any of the following  
31 conditions or treatments towards the prescription benefit cap for an adult  
32 Medicaid beneficiary per month:

33 (1) High blood pressure;

34 (2) Hypercholesteriolemlia;

35 (3) Blood modifiers;

36 (4) Diabetes; or

(5) Inhalers to treat respiratory illness.

(d) On or before January 1, 2022, the Department of Human Services shall submit and apply for any federal waivers, Medicaid state plan amendments, or other authority necessary to implement this section.

(e) Quarterly, the department shall report on the progress and implementation of this section to:

(1) The Senate Committee on Public Health, Welfare, and Labor;  
and

(2) The House Committee on Public Health, Welfare, and Labor.
