20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. REGULAR SALARIES - OFFICE OF THE SECRETARY. There is hereby

3 SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
4 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. USE OF  
5 ADVA CONTINGENCY POSITION POOL AND CONTINGENCY APPROPRIATION. In the event  
6 additional appropriation becomes necessary that is not authorized or  
7 contemplated in State Operations, Veterans' Homes and Veterans' Cemeteries  
8 appropriations of this Act and growth in the State Veterans' Home at  
9 Fayetteville's or North Little Rock's resident census and/or growth in the  
10 number of interments at the State Veterans' Cemetery at North Little Rock  
11 makes it necessary for the Arkansas Department of Veterans' Affairs to  
12 request additional positions, regular salaries and personal services matching  
13 appropriation in order to carry out the objectives of the Agency, the ADVA  
14 Contingency Position Pool and Contingency Appropriation authorized herein may  
15 be used for regular salaries and personal services matching line items.

16 The Arkansas Department of Veterans' Affairs Contingency Appropriation  
17 authorized herein shall be funded primarily with cash funds of the State  
18 Veterans' Home at Fayetteville or North Little Rock and of the State  
19 Veterans' Cemetery at North Little Rock or Birdeye. Each entity's cash funds  
20 shall be utilized in support of its own business operations and shall not be  
21 co-mingled. In addition, general revenue funding in support of the ADVA  
22 Contingency Position Pool shall be limited to \$250,000 per year.

23 Use of the ADVA Contingency Position Pool and Contingency Appropriation  
24 authorized in this Act shall be conditioned upon approval by the Chief Fiscal  
25 Officer of the State and upon certification by the Secretary of the Arkansas  
26 Department of Veterans' Affairs that funds are available to support the  
27 contingency positions requested and upon prior review by the Arkansas  
28 Legislative Council or Joint Budget Committee.

29 The General Assembly has determined that the Arkansas State Veterans'  
30 Home at Fayetteville and the Arkansas State Veterans' Cemetery at North  
31 Little Rock may operate more efficiently if some flexibility is provided to  
32 the Arkansas Department of Veterans' Affairs under this Section.

 16 SECTION 17. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
 17 authorized by this act shall be limited to the appropriation for such agency  
 18 and funds made available by law for the support of such appropriations; and  
 19 the restrictions of the State Procurement Law, the General Accounting and  
 20 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 21 Procedures and Restrictions Act, or their successors, and other fiscal  
 22 control laws of this State, where applicable, and regulations promulgated by  
 23 the Department of Finance and Administration, as authorized by law, shall be  
 24 strictly complied with in disbursement of said funds.

25  
 26 SECTION 18. LEGISLATIVE INTENT. It is the intent of the General  
 27 Assembly that any funds disbursed under the authority of the appropriations  
 28 contained in this act shall be in compliance with the stated reasons for  
 29 which this act was adopted, as evidenced by the Agency Requests, Executive  
 30 Recommendations and Legislative Recommendations contained in the budget  
 31 manuals prepared by the Department of Finance and Administration, letters, or  
 32 summarized oral testimony in the official minutes of the Arkansas Legislative  
 33 Council or Joint Budget Committee which relate to its passage and adoption.

34  
 35 SECTION 19. EFFECTIVE DATE. This act is effective on and after July 1,  
 36 2022. **APPROVED: 2/22/22**
