Arkansas Code 14-186-203(a) is amended to read as follows: "(a)(1) The municipal port authority shall be created by ordinance of 17 18 the governing body of the city or town and shall be an instrumentality of the 19 city or town creating the authority. 20 (2) Any city or incorporated town in the State of Arkansas shall 21 have the right, by ordinance, to create and set up a port authority. The 22 authority shall consist of and be governed by a board of five (5) members, one 23 (1) of whom may be the mayor of the city or incorporated town creating the 24 authority . If the mayor is a member of the port authority, the mayor shall 25 be chairman. If the mayor is not a member of the port authority, the chairman 26 shall be elected by the members of the authority." 27 SECTION 2. All provisions of this act of a general and permanent nature 28 29 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 30 Revision Commission shall incorporate the same in the Code. 31 SECTION 3. If any provision of this act or the application thereof to 32 33 any person or circumstance is held invalid, such invalidity shall not affect 34 other provisions or applications of the act which can be given effect without 35 the invalid provision or application, and to this end the provisions of this 36 act are declared to be severable.

2	SECTION 4. All laws or parts of laws in conflict with this act are
3	hereby repealed.
4	
5	SECTION 5. Emergency. It is hereby found and determined by the
6	Seventy-Eighth General Assembly that the present law provides that the mayor
7	of the city or incorporated town creating a port authority shall be a member
8	of the governing board and shall be chairman; that the law should provide that
9	the mayor may be a member of the board; and that this act would provide an
10	option for the mayor to serve on the board and serve as chairman or to not
11	serve on the board and appoint another member to be chairman. Therefore, an
12	emergency is hereby declared to exist and this act being necessary for the
13	immediate preservation of the public peace, health and safety shall be in full
14	force and effect from and after its passage and approval.
