23	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25	SECTION 1. Arkansas Code Title 9, Chapter 11, Subchapter 1 is amended
26	by adding the following new section:
27	"9-11-109. Same Sex Marriage Void.
28	Marriage shall be only between a man and a woman. A marriage between
29	persons of the same sex is void."
30	
31	SECTION 2. Arkansas Code 9-11-107 is amended to read as follows:
32	"9-11-107. Validity of foreign marriages.
33	All marriages contracted outside this state which would be valid by the
34	laws of the state or country in which the marriages were consummated and in
35	which the parties then actually resided shall be valid in all the courts in
36	this state. This section shall not apply to a marriage between persons of the

1 same sex." SECTION 3. All provisions of this act of a general and permanent nature 4 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 5 Revision Commission shall incorporate the same in the Code. SECTION 4. If any provision of this act or the application thereof to 8 any person or circumstance is held invalid, such invalidity shall not affect 9 other provisions or applications of the act which can be given effect without 10 the invalid provision or application, and to this end the provisions of this 11 act are declared to be severable. SECTION 5. All laws and parts of laws in conflict with this act are 14 hereby repealed. /s/Rep. Kidd et al APPROVED:2-13-97
