Arkansas Code 7-7-305(c) is amended to read as follows: 21 22 "(c) Any person who shall file for any elective office in this state may use not more than three (3) given names, one of which may be a nickname or 23 any other word used for the purpose of identifying such person to the voters 24 and may add as a prefix to his name the title or an abbreviation of an 25 elective public office the person currently holds. A nickname shall not 26 include professional or honorary titles. The names and titles proposed to be 27 28 used by each candidate shall be reviewed within twenty (20) days of the filing 29 deadline by the State Board of Election Commissioners for state offices and by the County Board of Election Commissioners for county, township, school, and 30 municipal offices. The name of every candidate shall be printed on the ballot 31 in the form as certified by either the State Board of Election Commissioners 32 or the County Board of Election Commissioners. No candidate shall be 33 permitted to change the form in which his name will be printed on the ballot 34 35 after the deadline for filing the political practice pledge. 5	SECTION 2. All provisions of this act of a general and permanent nature
6	are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
7	Revision Commission shall incorporate the same in the Code.

9	SECTION 3. If any provision of this act or the application thereof to
10	any person or circumstance is held invalid, such invalidity shall not affect
11	other provisions or applications of the act which can be given effect without
12	the invalid provision or application, and to this end the provisions of this
13	act are declared to be severable.

15	SECTION 4. All laws and parts of laws in conflict with this act are
16	hereby repealed.
