

1 Governor from a list of persons submitted to him or her by the Arkansas 2 Municipal League; and 3 (4) One (1) person who is not a member, retirant, or beneficiary of the system and who is not a member of the governing body of any political 4 5 subdivision to be appointed trustee by the Governor from a list of persons 6 submitted to him or her by the Joint Committee on Public Retirement and 7 Social Security Programs-; 8 (5) One (1) person who is a retired municipal police officer to 9 be appointed a member trustee by the Governor from a list of two (2) persons 10 submitted to him or her by the cochairs of the Joint Committee on Public 11 Retirement and Social Security Programs; and 12 (6) One (1) person who is a retired municipal fire fighter to be 13 appointed a member trustee by the Governor from a list of two (2) persons 14 submitted to him or her by the cochairs of the Joint Committee on Public 15 Retirement and Social Security. 16 (b)(1) The normal term of office for a trustee shall be four (4) years 17 from January 1 next following his or her election or appointment, as the case 18 may be. 19 (2) Each trustee shall continue to serve as trustee until a 20 successor is appointed and has qualified. 21 (c) Trustees elected or appointed as member trustees shall be retired 22 or active members of the system, but not more than one (1) member trustee shall be employed or formerly employed by any one (1) employer, not more than 23 one (1) member trustee two (2) member trustees shall be a police officer or a 24 25 retired police officer, and not more than one (1) member trustee two (2) 26 member trustees shall be a fire fighter or a retired fire fighter. 27 (d) Trustees appointed as employer trustees shall be elected or 28 appointed officials of employers with management experience and shall not be 29 members of the system, but not more than one (1) employer trustee shall be 30 from any one (1) employer. 31 (e) Whenever the Governor is to appoint a trustee, the list of persons 32 submitted to him or her shall consist of the names of two (2) persons. 33 34 SECTION 2. (a) This act is effective January 1, 2004. 35 (b)(1) Under section 1 of this act, the initial new two (2) member trustees to be appointed by Governor from lists submitted by the cochairs of 36
