1 There is established a program to be known as the "Emergency Secondary 2 Education Loan Program". 3 4 6-81-503. Program termination. 5 The program established by this subchapter shall be continued until 6 such time as the Director of General Education of the Department of Education 7 shall certify to the Governor and General Assembly that there is no longer an 8 emergency need for secondary school teachers of mathematics and the sciences 9 in Arkansas. 10 6-81-504. Administration - Authority of department. 11 12 This program shall be administered by the Department of Higher 13 Education, which shall have the authority, in consultation with the Emergency Secondary Education Loan Program Advisory Committee as provided for in this 14 15 subchapter, to establish necessary rules, regulations, procedures, and 16 selection criteria for the administration of the program and to designate 17 necessary forms and loan repayment schedules. 18 19 6-81-505. Advisory committee. 20 (a) The Department of Higher Education shall establish and consult 21 with the Emergency Secondary Education Loan Program Advisory Committee, which 22 shall consist of three (3) members appointed annually on July 1 by the Director of the Department of Higher Education and three (3) members 23 24 appointed by the Director of General Education of the Department of 25 Education. 26 (b) The committee shall advise in the establishment of program rules, 27 regulations, procedures, and selection criteria and shall recommend 28 individuals to be awarded loans. 29 30 6-81-506. Eligibility. 31 From funds appropriated for the student assistance grant program, as 32 authorized by §§ 6-82-201 - 6-82-213, the Department of Higher Education may 33 make loans to students under the following conditions: 34 (1) Loan recipients shall be bona fide residents of the State of 35 Arkansas, as defined by the Department of Higher Education, and be citizens 36 of the United States or permanent resident aliens;

1	(2) Loan recipients shall be enrolled full-time in a regionally
2	accredited public or independent college or university in Arkansas with a
3	teacher education program which has been approved by the Department of
4	Education or in a regionally accredited two-year institution in Arkansas
5	where those courses taken are directly creditable toward such program;
6	(3) A loan recipient shall be enrolled as a major in a program
7	of study leading to secondary teacher certification in Arkansas in
8	mathematics, chemistry, physics, biology, physical science, or general
9	science, or shall have completed a program of study as a major in such field
10	culminating in a baccalaureate degree, and shall be enrolled in a program
11	leading to secondary teacher certification in Arkansas;
12	(4) Loan recipients shall declare an intention to teach the
13	subjects specified in this subchapter in a secondary school in Arkansas; and
14	(5) Loan recipients shall maintain a cumulative grade point
15	average in their college work of no less than 2.5 on a 4.0 scholastic grading
16	scale or appropriate equivalent as determined by the Department of Higher
17	Education.
18	
19	6-81-507. Selection of loan recipients.
20	(a) The final responsibility for selecting loan recipients shall rest
21	jointly with the Director of the Department of Higher Education and the
22	Director of General Education of the Department of Education.
23	(b)(l) Priority in the awarding of loans shall be given to those
24	applicants who have demonstrated the greatest academic ability.
25	(2) In cases where two (2) or more applicants receive the same
26	priority rating, the advantage shall be given to the student who can become
27	certified in the shortest period of time.
28	
29	6-81-508. Maximum amount of loans.
30	(a) Students may receive loans up to, but not in excess of, one half
31	(1/2) of the cost of student fees, room and board, and books and
32	instructional supplies at the institution to be attended.
33	(b) No student shall receive a loan that, when totaled with all other
34	sources of student financial assistance, exceeds the total cost of education
35	at the institution to be attended.

1	6-81-509. Duration of loans.	
2	Students may receive loans for a maximum of four (4) academic years or	
3	until such time as they have completed certification to teach in Arkansas,	
4	whichever shall come first.	
5		
6	6-81-510. Cancellation or repayment of loans - Failure to repay.	
7	(a) Loan recipients who teach full-time in a secondary school in	
8	Arkansas following certification in a subject field as specified in this	
9	subchapter shall, upon annual certification by an appropriate school	
10	official, have one-fifth (1/5) of the total loan, and related interest,	
11	forgiven for each year employed in such capacity to a maximum of five (5)	
12	years when the total loan and accumulated interest will be forgiven.	
13	(b) Loan recipients who do not teach full-time in a secondary school	
14	in Arkansas in a herein specified field upon completing their program of	
15	study, who discontinue their teaching at any time within five (5) years	
16	following completion of the program of study, or who discontinue their	
17	studies prior to completing their program of study shall, within a maximum of	
18	five (5) years, repay the full remaining loan balance plus accrued interest	
19	according to an interest and repayment schedule developed by the Department	
20	of Higher Education.	
21	(c) Loan recipients required to repay loans as provided in subsection	
22	(b) of this section who fail to meet their repayment obligations may have	
23	added to their total obligation any costs for collection of the debt and	
24	shall have their teaching certification in Arkansas revoked.	
25		
26	6-81-511. Expansion of program.	
27	Upon certification by the State Board of Education that a shortage of	
28	teachers exists in Arkansas in one (1) or more teaching fields other than	
29	mathematics and the sciences, students may receive loans under the conditions	
30	stated in this subchapter for study in such shortage fields.	
31		
32	SECTION 2. Arkansas Code Title 6, Chapter 81, is amended to add an	
33	additional subchapter to read as follows:	
34	<u>6-81-1401. Title.</u>	
35	This subchapter shall be known and may be cited as the "State Teacher	
36	Assistance Resource Program"

2	6-81-1402. Definitions.
3	For purposes of this subchapter:
4	(1) "Five-year teacher education program" means a program within a
5	regionally accredited institution of higher education in Arkansas that will
6	lead to obtaining a teacher certification and designed for completion in five
7	(5) years with an award of a master's degree in education; and
8	(2) "Four-year teacher education program" means a program within a
9	regionally accredited institution of higher education in Arkansas that will
10	lead to obtaining a teacher certification and designed for completion in four
11	(4) years with an award of a baccalaureate degree in education.
12	
13	6-81-1403. Creation - Purpose.
14	(a) There is created the State Teacher Assistance Resource Program.
15	(b) While in college, the State Teacher Assistance Resource should be
16	exposed to a range of extracurricular activities geared toward instilling a
17	strong motivation not only to remain in teaching but to provide leadership
18	for tomorrow's schools.
19	
20	6-81-1404. Administration of and authority of the Department of Higher
21	Education.
22	(a) The State Teacher Assistance Resource Program shall be
23	administered by the Department of Higher Education.
24	(b) The department shall adopt standards for awarding the forgivable
25	loans to ensure that only students in their junior and senior year who are
26	admitted to a teacher education program with the best potential for success
27	receive a forgivable loan.
28	(c) The department shall administer the program in cooperation with
29	teacher training institutions selected by the department.
30	(d)(1) The requirements of this subchapter are contingent on the
31	funding available for the State Teacher Assistance Resource Program.
32	(2) The Department of Higher Education may use funds
33	appropriated for the Emergency Secondary Education Loan programs and other
34	available funds to fund the State Teacher Assistance Resource Program.
35	(e) The department may determine the necessary procedures for the
36	awarding of forgivable loans should the number of eligible applicants and

1 recipients exceed the funds available, but priority consideration shall be 2 given based on. 3 4 6-81-1405. Eligibility. 5 A students enter his or her junior or senior year and are admitted to a 6 teacher education program shall be eligible to receive a forgivable loan under the State Teacher Assistance Resource Program, if: 7 8 (1) The recipient earns a cumulative grade point average of 2.75 or 9 above on a 4.0 scale at an approved institution; 10 (2) The recipient has completed a total of at least twenty-seven (27) 11 hours during the first full academic year and a total of at least thirty (30) 12 hours per academic year thereafter; (3) If the student is entering the junior year, the student has taken 13 the standardized rising junior test provided for in § 6-61-114; and 14 15 (4) The recipient meets any other continuing eligibility criteria 16 established by the department. 17 6-81-1406. Duration - Amount - Repayment. 18 19 (a)(1) The State Teacher Assistance Resource Program shall be used to 20 provide: 21 (A) A two-year forgivable loan if the recipient is in a 22 four-year teacher education program, or a three-year forgivable loan if the 23 recipient is in a five-year teacher education program, in the amount of three 24 thousand dollars (\$3,000) per year for a junior or senior admitted to a 25 teacher education program who commits to teach in a public school located in 26 a geographical area of the state designated as having a critical shortage of 27 teachers or in a subject matter area designated as having a critical shortage 28 of teachers; 29 (B) A two-year forgivable loan if the recipient is in a 30 four-year teacher education program, or a three-year forgivable loan if the recipient is in a five-year teacher education program, in the amount of six 31 32 thousand dollars (\$6,000) per year for a junior or senior admitted to a 33 teacher education program who commits to teach in a public school located in 34 a geographical area of the state designated as having a shortage of critical 35 teachers and in a subject matter area designated as having a critical 36 shortage of teachers;

1	(C) A loan repayment for federal students loans in the
2	amount of three thousand dollars (\$3,000) per year for each year a certified
3	teacher, who graduated from a teacher education program after April 2004,
4	teaches in a public school located in a geographical area of the state
5	designated as having a critical shortage of teachers; or
6	(D) A loan repayment for federal students loans in the
7	amount of six thousand dollars (\$6,000) per year for each year a certified
8	teacher, who graduated from a teacher education program after April 2004,
9	teaches in a public school located in a geographical area of the state
10	designated as having a critical shortage of teachers and in a subject matter
11	designated as having a critical shortage of teachers.
12	(2) No person receiving a forgivable-loan under subdivisions
13	(a)(1)(A) or $(a)(1)(B)$ of this section shall be eligible to receive a loan
14	repayment under subdivisions (a)(1)(C) of (a)(1)(D) of this section.
15	(b)(1) A student may receive a State Teacher Assistance Resource
16	Program and Academic Challenge Scholarship or Governor's Distinguished
17	Scholarships, to the extent the receipt of both awards would not violated the
18	provisions of § 6-80-105.
19	(2) For purpose of compliance with § 6-80-105, the forgivable
20	loans under this program shall be considered public funds.
21	(3) No student may participate in more than one (1) forgivable
22	loan program supported with state money.
23	(c) Loan recipients shall execute a note made payable to the
24	Department of Higher Education that shall bear interest at the rate to be
25	determined by the Department of Higher Education at the time of the award to
26	begin accruing on September 1 after completion of the program, or immediately
27	after termination of the forgivable loan, whichever is earlier.
28	(d) The forgivable loan may be terminated if:
29	(1) The recipient withdraws from school;
30	(2) The recipient does not meet the standards set by the
31	Department of Higher Education; or
32	(3) For other reasons as designated by the Department of Higher
33	Education.
34	(e) Within nine (9) months after completion of the teacher education
35	program the recipient of a forgivable loan under the State Teacher Assistance
36	Resource program shall begin to teach in a public school in the state in

- 1 accordance with the student's initial commitment
- 2 or shall be begin to repaying the loan in accordance with the terms of note
- 3 <u>executed under subsection (c) of this section.</u>
- 4 (1) The Department of Higher Education shall forgive one (1)
- 5 year of the loan for each consecutive year the recipient teaches full-time in
- 6 a shortage area in accordance with the terms of the recipient's initial
- 7 commitment beginning nine (9) months from the date of graduation.
- 8 (2) The Department of Higher Education may grant loan repayment
- 9 <u>deferrals to students who enrolled in masters or doctoral programs after</u>
- 10 <u>completion of a four-year or five-year teacher education program or for other</u>
- 11 just cause as determined by the Department of Higher Education.
- 12 <u>(3) The Department of Higher Education may also forgive the loan</u>
- 13 if it finds that it is impossible for the recipient to teach in an Arkansas
- 14 public school as required, because of the death or permanent disability of
- 15 <u>the recipient.</u>
- 16 (f) Loan recipients required to repay loans as provided in subsection
- 17 (e) of this section who fail to meet their repayment obligations may have
- 18 added to their total obligation any costs for collection of the debt and
- 19 shall have their teaching license in Arkansas revoked by the State Board of
- 20 Education.
- 21 (g)(1) All funds appropriated to or otherwise received by the State
- 22 Teacher Assistance Resource Program for forgivable loans, all funds received
- 23 as repayment of forgivable loans, and all interest earned on these funds,
- 24 <u>shall be placed in a revolving fund.</u>
- 25 <u>(2) This revolving fund shall be used for forgivable loans</u>
- 26 granted under the State Teacher Assistance Resource Program.
- 27 (h)(1) The Department of Higher Education, as administrator for the
- 28 State Teacher Assistance Resource Program, may use up to fifty thousand
- 29 dollars (\$50,000) annually from the fund balance for costs associated with
- 30 administration of the State Teacher Assistance Resource Program.
- 31 (2) These funds are in addition to funds required for collection
- 32 costs related to loan repayments.
- 33 (i) Any recipient of an Emergency Secondary Education Loan may qualify
- 34 for a forgivable loan under State Teacher Assistance Resource Program, and
- 35 shall continue to fulfill any existing obligation under the terms of any
- 36 <u>loans received under the Emergency Secondary Education Loan program.</u>

1	(j) The Department of Higher Education shall promulgate regulations
2	necessary of for the implementation of the State Teacher Assistance Resource
3	Program.
4	
5	6-81-1407. State Teacher Assistance Resource Commission.
6	(a) There is established a commission to be known as "The State
7	Teacher Assistance Resource Commission".
8	(b) The commission shall consist of eleven (11) members as follows:
9	(1) The Lieutenant Governor, or his or her designee;
10	(2) The chairperson of the State Board of Education, or his or
11	her designee;
12	(3) Three (3) persons appointed by the Governor;
13	(4) Three (3) persons appointed by the President Pro Tempore of
14	the Senate; and
15	(5) Three (3) persons appointed by the Speaker of the House of
16	Representatives.
17	(c) The appointed commission members shall be:
18	(1) Individuals who have demonstrated a commitment to education;
19	<u>and</u>
20	(2) Residents of the State of Arkansas at the time of
21	appointment and throughout his or her term.
22	(d)(1) In 2003, three (3) members shall be appointed by the Speaker of
23	the House of Representatives as follows:
24	(A) One (1) for a term to expire June 30, 2005;
25	(B) One (1) for a term to expire June 30, 2006; and
26	(C) One (1) for a term to expire June 30, 2007.
27	(2) In 2003, three (3) members shall be appointed by the
28	President Pro Tempore of the Senate as follows:
29	(A) One (1) for a term to expire June 30, 2005;
30	(B) One (1) for a term to expire June 30, 2006; and
31	(C) One (1) for a term to expire June 30, 2007.
32	(3) In 2003, three (3) members shall be appointed by the
33	Governor as follows:
34	(A) One (1) for a term to expire June 30, 2005;
35	(B) One (1) for a term to expire June 30, 2006; and
36	(C) One (1) for a term to expire June $30-2007$

1	(4) Subsequent appointments are for a term of four (4) years.	
2	(e)(1) If a vacancy occurs in an appointed position, for any reason,	
3	the vacancy shall be filled by appointment by the official that made the	
4	appointment.	
5	(2) The new appointee shall serve for the remainder of the	
6	unexpired term.	
7	(f) The Lieutenant Governor or his or her designee shall serve as	
8	chairperson.	
9	(g)(1) The commission shall meet at times and places the chairperson	
10	deems necessary, but no meetings shall be held outside of the State of	
11	Arkansas.	
12	(2) A majority of the members of the commission shall constitute	
13	a quorum for the purpose of transacting business.	
14	(3) All action of the commission shall be by a majority vote of	
15	the full membership of the commission.	
16	(h) The commission shall:	
17	(1) Promote the State Teacher Assistance Resource Program and	
18	encourage participation by high school students; and	
19	(2) Select the recipients of the State Teacher Assistance	
20	Resource forgivable loans.	
21	(i)(1) The Department of Higher Education shall provide staff and	
22	office space to the commission.	
23	(2)(A) Members of the commission shall serve without pay.	
24	(B) Members of the commission may receive expense	
25	reimbursement in accordance with § 25-16-902, to be paid by the Department of	
26	Higher Education to the extent money is available.
