23	SECTION 1. Arkansas Code § 27-16-701(c), concerning the application		
24	for driver license, is amended to read as follows:		
25	(c)(1) Every	application form for an instruction per	nit, a commercial
26	or noncommercial dri	ver's license, or any renewal of these	licenses or
27	permits shall include	e space for the applicant's social secur	rity number if he
28	or she has been assigned such a number.		
29	(2) Eve	ry applicant shall supply his or her so	cial security
30	number on the application form when he or she has been assigned such a		
31	number, except that an applicant for an instruction permit for a		
32	noncommercial driver's license shall not be required to supply his or her		
33	social security number and may choose whether to use his or her social		
34	security number on t	he application.

36	SECTION 2. Ar	kansas Code § 27-16-801(a)(4), concerni:	ng the issuance of

1	driver license numbers, is amended to read as follows:		
2	(4) $\frac{(A)}{(A)}$ At the time of initial issuance or at the time of renewal		
3	of a license, the distinguishing number assigned to the licensee for his or		
4	her license shall be the same as the licensee's social security number when		
5	the licensee has been assigned a social security number or shall be a nine-		
6	digit number assigned to the specific licensee by the commissioner when the		
7	licensee has not been assigned a social security number.		
8	(B) However, an applicant for the issuance or renewal of a		
9	Class D, Class M, or Class MD license may choose whether to use his or her		
10	social security number or a nine-digit number assigned by the commissioner as		
11	his or her license number.

13	SECTION 3. Arkansas Code § 27-23-111(a), concerning the content of a		
14	commercial driver license, is amended to read as follows:		
15	(a) Content of License. The commercial driver license must be marked		
16	"Commercial Driver License" or "CDL", and must be, to the maximum extent		
17	practicable, tamperproof. It must include, but not be limited to, the		
18	following information:		
19	(1) The name and residential address of the person;		
20	(2) The person's color photograph;		
21	(3) A physical description of the person including sex and		
22	height;		
23	(4) Date of birth;		
24	(5) A license number which may shall be the person's social		
25	security number or a nine-digit number assigned to the person by the		
26	commissioner if the person elects not to use the social security number as		
27	the license number;		
28	(6) The person's signature;		
29	(7) The class or type of commercial motor vehicle or vehicles		
30	which the person is authorized to drive together with any endorsements or		
31	restrictions;		
32	(8) The name of this state; and		
33	(9) The dates between which the license is valid.
