21	SECTION 2. EMERGENCY CLAUSE. It is found and determined by the		
22	General Assembly of the State of Arkansas that farmers have a primary		
23	harvesting season that begins in early Spring and continues throughout the		
24	Summer and Fall; that farmers' markets begin to open and sell their produce		
25	in early Spring and sell continuously throughout the Spring, Summer, and		
26	Fall; that in order for the farmers to reap the benefit of their labors		
27	during this growing and harvesting season this act must be enacted with all		
28	due haste. Therefore, an emergency is declared to exist and this act being		
29	immediately necessary for the preservation of the public peace, health, and		
30	safety shall become effective on:		
31	(1) The date of its approval by the Governor;		
32	(2) If the bill is neither approved nor vetoed by the Governor,		
33	the expiration of the period of time during which the Governor may veto the		
34	<u>bill; or</u>		
35	(3) If the bill is vetoed by the Governor and the veto is		
36	overridden, the date the last house overrides the veto.
