2	(3) "Person" means an individual, corporation, partnership,
3	limited liability company, firm, association, trust, estate, public or
4	private institution, group, agency, political subdivision of this state, any
5	other state, or political subdivision or agency of this state, and any legal
6	successor, representative, agent, or agency of these entities;
7	(4) "Tanning equipment" means ultraviolet or other lamps and
8	equipment containing these lamps intended to induce skin tanning through the

24	Before allowing an initial exposure at a tanning facility of a person
25	under eighteen (18) years of age, the owner or operator shall witness the
26	person's parent or legal guardian signing and dating a warning statement as
27	follows:

29	"WARNING STATEMENT
30	This statement must be read and signed by a parent or legal guardian of
31	any person under eighteen (18) years of age before allowing the initial
32	exposure at this tanning facility.
33	DANGER — ULTRAVIOLET RADIATION WARNING
34	Follow instructions.
35	Avoid overexposure. As with natural sunlight, overexposure can cause
36	eye and skin injury and allergic reactions. Repeated exposure may cause

1	premature aging of the skin and skin cancer.
2	Wear protective eyewear. FAILURE TO USE PROTECTIVE EYEWEAR MAY RESULT
3	IN SEVERE BURNS OR LONG-TERM INJURY TO THE EYES.
4	Medications or cosmetics may increase your sensitivity to the
5	ultraviolet radiation. Consult a physician before using sunlamp or tanning
6	equipment if you are using medications or have a history of skin problems or
7	believe yourself to be especially sensitive to sunlight.
