3	SECTION 2. Arkansas Code § 16-110-407(a), concerning the time period
4	in which to answer in a garnishment proceeding, is amended to read as
5	follows:
6	(a) If any garnishee, after having been duly served with a writ of
7	garnishment, shall neglect or refuse to answer the interrogatories exhibited
8	to him or her, on or before twenty (20) thirty (30) days after service of the
9	writ, the court, upon motion of the plaintiff, may issue a notice to the
10	garnishee, requiring him or her to appear personally at a hearing not later
11	than ten (10) days after receipt of said notice or at such other later date
12	as the court may fix and answer the allegations and interrogatories of the
13	plaintiff. Service of the notice may be made either by the clerk, or by the
14	plaintiff, by any method prescribed by Arkansas Rules of Civil Procedure for
15	service of notice.
