21	outside of his or her jurisdiction if:

8	(E)(i) An opportunity for the person receiving the		
9	citation to sign the citation.		
10	(ii) If the person who is to receive the citation		
11	refuses to sign the citation, the school resource officer is required to		
12	arrest the person and deliver him or her to the local law enforcement agency		
13	having jurisdiction immediately.		
14	(2) The school resource officer shall file a copy of the		
15	citation issued under this section at least fifteen (15) days before the		
16	court date listed on the citation.		
17	(3) The school resource officer shall provide a person receiving		
18	a citation under this section a full and complete copy of the citation.
