SECTION 2. Arkansas Code § 23-81-903(5), concerning the definition of "policy" under the Unclaimed Life Insurance Benefits Act, is amended to read as follows: (5)(A) "Policy" means a policy or certificate of life insurance issued in this state that provides a death benefit. (B) "Policy" does not include: (i) A policy or certificate of life insurance that provides a death benefit under: (a) A defined employee benefit pension plan, as defined in Section 3(35) of the Employee Retirement Income Security Act of 1974, Pub. L. No. 93-406; or (b) Any federal employee benefit program; (ii) A policy or certificate of life insurance that is used to fund a preneed funeral contract or prearrangement funeral or related expenses or a prepaid funeral benefits contract; (iii) A policy or certificate of credit life or accidental death insurance; or (iv) A policy issued to a group master policyholder for which the insurer does not provide recordkeeping services; APPROVED: 03/03/2017
