16 (3) Each Agency, Board, Commission or Institution shall provide a 17 written report to the Arkansas Legislative Council or Joint Budget Committee 18 containing all information set forth in item (2) above, along with a written 19 statement as to the current status of the project, contract, purpose etc. for 20 which the carry forward was originally requested no later than thirty (30) 21 days prior to the time the Agency, Board, Commission or Institution presents 22 its budget request to the Arkansas Legislative Council/Joint Budget 23 Committee; and

(4) Thereupon, the Department of Finance and Administration shall
include all information obtained in item (3) above in the budget manuals
and/or a statement of non-compliance by the Agency, Board, Commission or
Institution.

The provisions of this section shall be in effect only from July 1, $\frac{2016}{29}$ 29 $\frac{2017}{2017}$ through June 30, $\frac{2017}{2018}$.

31 SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 32 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SALARY OF 33 THE COMMISSIONER OF THE DEPARTMENT OF EDUCATION. It is the intent of the 34 General Assembly that the appropriation for the salary of the Commissioner of 35 the Department of Education shall be the sole and exclusive authority for his 36 or her salary. It is further the intent of the General Assembly that the

1 Commissioner be required to devote all of his or her working time exclusively 2 to the performance of his or her duties as Commissioner of the Department of Therefore, the Commissioner of the Department of Education is 3 Education. 4 hereby prohibited from accepting any additional salary from any other source 5 (including state, federal, or private entities or persons) for the 6 performance of his or her duties as Commissioner, and is prohibited from 7 accepting any salary, fees or compensation from any other source (including 8 state, federal or private entities or persons) for any other employment of 9 any kind outside the scope of his or her duties as Commissioner, including 10 but not limited to consulting work for any other public or private entity. 11 This section shall not be construed to prohibit the Commissioner from 12 accepting or receiving expense reimbursements and employee benefits as 13 provided by State law.

17 SECTION 22. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 18 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 19 ESTABLISHMENT OF A "POSITION POOL". (a) To address needs emerging from 20 statewide education issues and the necessity of recruiting and retaining 21 qualified personnel, the Arkansas Department of Education or its successor 22 agency is authorized for the 2016-2017 2017-2018 fiscal year a pool of no 23 more than five (5) Professional/Executive positions at a salary not to exceed 24 the maximum salary for a grade N912. These positions are to be used by the 25 Department of Education in the event that the personal services needs of the 26 Department during the 2016-2017 2017-2018 fiscal year require additional 27 positions, either by title or in number, that are not authorized by the 28 General Assembly in the Regular Salaries section of this Act. These positions 29 may also be used to properly classify positions when the Department does not 30 have a vacant position available with the appropriate title and salary level.

(b) To address needs emerging from statewide education issues and the necessity of recruiting and retaining qualified personnel, the Arkansas Department of Education or its successor agency is authorized for the 2016– 2017 2017-2018 fiscal year a pool of ten (10) classified positions at up to a grade C130. These positions are to be used by the Department of Education in the event that the personal services needs of the Department during the 2016– 2016-

1 2017 2017-2018 fiscal year require additional positions, either by

2 classification or in number, that are not authorized by the General Assembly 3 in the Regular Salaries section of this Act. These positions may also be used 4 to properly classify positions when the Department does not have a vacant 5 position available with the appropriate title and grade level.

6 (c) Any salary determinations or adjustments administered under the
7 provisions of Subsections (a) and (b) of this Section shall be made by
8 comparing the qualifications and salary levels of similar employees in school
9 districts or in other state education agencies.

10 (d) The Department of Education is authorized to access the pool 11 positions authorized in this Section at any time when it is determined by the 12 Commissioner that the need exists. The Commissioner shall provide a monthly report of the justification for the need to allocate titles from this growth 13 14 pool to the Chief Fiscal Officer of the State and to the Arkansas Legislative 15 Council or Joint Budget Committee for review. The report shall also include 16 an accounting of the names, titles, and salaries of personnel whose salaries 17 have been adjusted under provisions of Subsections (a) and (b) of this 18 Section.

(e) If the Department of Education requests continuation of any "Position Pool" position(s) as established herein during the next fiscal year, the position(s) must be requested as a new position(s) in the agency's budget request.

23 (f) Determining the number of personnel to be employed by a state agency 24 is the prerogative of the General Assembly and is usually accomplished by 25 delineating the maximum number of personnel by identifying job titles and the 26 maximum grade or salary attached to those titles. The General Assembly has 27 determined that the Arkansas Department of Education could be operated more 28 efficiently if some flexibility is given to that agency. That flexibility is 29 being accomplished by providing a position pool in Subsections (a) and (b) of 30 this Section and since the General Assembly has granted the agency broad 31 powers under the growth pool concept, it is both necessary and appropriate 32 that the General Assembly maintain oversight of the utilization of the 33 position pool by requiring review of the Legislative Council or Joint Budget 34 Committee in the utilization of the position pool. Therefore, the requirement 35 of review by the Legislative Council or Joint Budget Committee is not a 36 severable part of this section. If the requirement of review by the

Legislative Council <u>or Joint Budget Committee</u> is ruled unconstitutional by a court of competent jurisdiction, this entire section is void.

6 SECTION 23. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 7 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS 8 LEADERSHIP ACADEMY - REDUCTION OF FUNDS RESTRICTION. Upon determination by 9 the Department of Education that a reduction in the amount of available 10 appropriation within the Department of Education Fund Account is required 11 from the amount appropriated, the reduction in the available appropriation 12 from the full amount appropriated for the Arkansas Leadership Academy shall 13 be limited to the average percentage reduction in the other appropriations to 14 the Department of Education from the Department of Education Fund Account. 15 The provisions of this section shall be in effect only from July 1, 2016 16 2017 through June 30, 2017 2018.

18 SECTION 24. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 19 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 20 LEADERSHIP ACADEMY. The funds appropriated in the "AR LEADERSHIP ACADEMY" 21 line item in the State Operations Appropriation Section of this Act shall be 22 used for the School Support Program which will provide support to schools or 23 school districts designated by the Department of Education as being in school 24 improvement status and to provide for general operations of the Leadership 25 Academy.

26 The provisions of this section shall be in effect only from July 1, $\frac{2016}{27}$ 27 $\frac{2017}{2017}$ through June 30, $\frac{2017}{2018}$.

SECTION 25. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. STATE FUND RESTRICTIONS. No state funds shall be used for abortion referral in public schools, or for abortion services. Funds shall be expended in accordance with Arkansas Code Annotated § 6-18-703.

The provisions of this section shall be in effect only from July 1, 2016
<u>2017</u> through June 30, 2017 <u>2018</u>.

1 SECTION 26. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 2 authorized by this act shall be limited to the appropriation for such agency 3 and funds made available by law for the support of such appropriations; and 4 the restrictions of the State Procurement Law, the General Accounting and 5 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 6 Procedures and Restrictions Act, or their successors, and other fiscal 7 control laws of this State, where applicable, and regulations promulgated by 8 the Department of Finance and Administration, as authorized by law, shall be 9 strictly complied with in disbursement of said funds.

11 SECTION 27. LEGISLATIVE INTENT. It is the intent of the General 12 Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for 13 14 which this act was adopted, as evidenced by the Agency Requests, Executive 15 Recommendations and Legislative Recommendations contained in the budget 16 manuals prepared by the Department of Finance and Administration, letters, or 17 summarized oral testimony in the official minutes of the Arkansas Legislative 18 Council or Joint Budget Committee which relate to its passage and adoption. 19

20 SECTION 28. EMERGENCY CLAUSE. It is found and determined by the 21 General Assembly, that the Constitution of the State of Arkansas prohibits 22 the appropriation of funds for more than a one (1) year period; that the 23 effectiveness of this Act on July 1, 2017 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in 24 25 the event of an extension of the legislative session, the delay in the 26 effective date of this Act beyond July 1, 2017 could work irreparable harm 27 upon the proper administration and provision of essential governmental programs.
