23	(a) The Department of Health, in coordination with the Arkansas Stat	e
24	Board of Nursing, shall establish the "Clinical Nurse Education Portal," if	
25	funds are available.	
26	(b) The portal shall:	
27	(1) Be a statewide management software system that contains	
28	information for all nursing programs in Arkansas in relation to clinical	
29	nursing placement access for nursing students and healthcare facilities;	
30	(2) Be compliant with the Family Educational Rights and Privac	у
31	Act of 1974, 20 U.S.C. § 1232g, and the Health Insurance Portability and	
32	Accountability Act of 1996;	
33	(3) Provide clinical access and utilization data to the board	<u>to</u>
34	inform future quality improvement initiatives;	
35	(4) Contain compliance, orientation, clinical schedules, and	
36	affiliation information for a clinical nursing placement; and

2	programs with clinical hour requirements, including simulation laboratory

4	(c) The department may contract with a non-state entity to establish
5	and maintain the portal.
6	(d)(1) All nursing programs and healthcare providers participating or
7	desire to participate in providing nursing clinical experiences shall have
8	access to the portal and the ability to manage clinical requests,
9	affiliations, and clinical compliance utilizing the software.
10	(2) A nursing program or healthcare provider is not required to
11	adopt the use of the portal as their primary clinical experience management
12	<u>software.</u>
13	(e)(1) On the year-anniversary of the effective date of this section
14	and annually thereafter, the department shall report on the implementation,
15	progress, and activity of the portal to the:
16	(A) Senate Committee on Public Health, Welfare, and Labor;
17	and
18	(B) House Committee on Public Health, Welfare, and Labor.
19	(2) The Chair of the Senate Committee on Public Health, Welfare,
20	and Labor or the Chair of the House Committee on Public Health, Welfare, and
21	Labor may request any additional reports at their discretion.
22	(f)(1) The portal may be funded by one-time funds under the American
23	Rescue Plan Act, if available and eligible, to fund personnel and build
24	software programs.
25	(2) In order to maintain the portal, the department may charge a
26	fee to nursing programs or healthcare providers, or both, that use the
27	portal.
28	(g) The department may expand the portal to include other disciplines
29	of healthcare professionals.
