22	SECTION 1. Ark	ansas Code Title 7, Chapter 9, is	amended to add an

27	7-9-701. Defin	<u>itions.</u>	
28	As used in this	subchapter:	
29	<u>(1) "Alt</u>	<u>ernate delegate" means a person s</u>	elected by the General
30	Assembly to represent	the State of Arkansas at an Arti	cle V Convention if the
31	originally chosen del	egate is not able to serve or vot	e ;
32	<u>(2)(A) "</u>	Article V Application" means the	document calling the
33	Article V Convention	adopted by:	
34		(i) The United States Congres	s, if the Article V
35	Convention is called	by the United States Congress und	er Article V of the
36	United States Constit	ution; and	

1	(ii) A state legislature if the Article V Convention
2	is called for by application of the legislatures of two-thirds $(2/3)$ of the
3	several states under Article V of the United States Constitution.
4	(B) The Article V Application under subdivision (3)(A)(ii)
5	of this section shall be made by joint resolution passed by the General
6	<pre>Assembly;</pre>
7	(3) "Article V Convention" means an interstate convention called
8	under Article V of the United States Constitution;
9	(4) "Delegate" means a person selected by the General Assembly
10	to represent the State of Arkansas at an Article V Convention, that may be
11	referred to as a commissioner of the State of Arkansas;
12	(5)(A) "Legislative instructions" means the instructions of the
13	General Assembly given to delegates and their alternate delegates regarding
14	the permitted scope of the Article V Convention.
15	(B) The General Assembly shall adopt legislative
16	instructions by joint resolution.
17	(C) Legislative instructions shall be consistent with the
18	scope of the convention as defined by the Article V Application passed by the
19	State of Arkansas and relied upon by the United States Congress to call the
20	Article V Convention; and
21	(6) Except as provided under subdivision (6)(B) of this section,
22	"unauthorized amendment" means a proposed amendment that:
23	(A) Does not reflect the amendment text in the Article V
24	Application under consideration; or
25	(B) Is outside the subject matter permitted under the
26	Article V Application as may be clarified by the legislative instructions.
27	
28	7-9-702. Delegates to an Article V Convention.
29	(a) The State of Arkansas shall appoint seven (7) delegates to an
30	Article V Convention as follows:
31	(1) Two (2) members of the Senate appointed by a majority vote
32	of the Senate who are serving at the time of the appointment;
33	(2) Three (3) members of the House of Representatives appointed
34	by a majority vote of the House of Representatives who are serving at the
35	time of the appointment; and
36	(3) Two (2) citizens of the State of Arkansas, selected by the

_	resident fro rempore of the behate and the speaker of the house of
2	Representative from a list of recommendations made by the Convention of
3	States Arkansas.
4	(b) The State of Arkansas shall appoint three (3) alternate delegates
5	to an Article V Convention as follows:
6	(1) One (1) member of the Senate appointed by a majority vote of
7	the Senate who are serving at the time of the appointment;
8	(2) One (1) member of the House of Representatives appointed by
9	a majority vote of the House of Representatives who are serving at the time
10	of the appointment; and
11	(3) One (1) citizen of the State of Arkansas, selected by the
12	President Pro Tempore of the Senate and the Speaker of the House of
13	Representative from a list of recommendations made by the Convention of
14	States Arkansas.
15	(c) The President Pro Tempore of the Senate and the Speaker of the
16	House of Representatives shall certify the selection of the delegate and
17	alternate delegate by written proclamation and provide a copy of the written
18	proclamation to the:
19	(1) Delegate;
20	(2) Alternate delegate;
21	(3) Secretary of State; and
22	(4) Article V Convention.
23	(d) A person shall not serve as a delegate or an alternate delegate
24	without the written proclamation in his or her name under subdivision (c) of
25	this section.
26	(e) An alternate delegate shall:
27	(1) Act in place of a delegate when they are absent from the
28	Article V Convention; and
29	(2) Replace a delegate if a delegate vacates the office.
30	(f) A delegate may only be replaced by the entity that selected the
31	delegate initially.
32	(g) In the event an alternate delegate permanently fills the vacancy
33	of a delegate, a new alternate delegate shall be selected by the body which
34	chose the original alternate delegate.
35	(h) Alternate delegates:
36	(1) May participate in caucus meetings of the Arkansas

	delegation to leview and discuss proposed amendments;
2	(2) May attend convention and committee meetings as observers;
3	(3) Shall not speak publicly on the record in any meetings while
4	still in alternate status; and
5	(4) Shall not vote to determine the Arkansas vote on a proposed
6	amendment while they are in alternate status.
7	(i)(l) Delegates and alternative delegates are entitled to receive the
8	same mileage, travel, and per diem expenses as those paid to members of the
9	General Assembly.
10	(2) All necessary expenses shall be paid from funds appropriated
11	by the General Assembly.
12	(3) Delegates and alternative delegates are not eligible for a
13	salary for the performance of these duties.
14	
15	7-9-703. Delegate to an Article V Convention — Duties and limitations.
16	(a) To be considered for the positions of delegate or alternate
17	delegate, a person shall take the following oath:
18	"I do solemnly swear or affirm that to the best of my abilities, I
19	will, as a delegate or alternate to an Article V Convention, uphold the
20	Arkansas Constitution, the United States Constitution, and laws of the United
21	States of America and the State of Arkansas. I will not vote to allow
22	consideration of, to consider, or to approve an unauthorized amendment
23	proposed for ratification to the United States Constitution. I agree to
24	faithfully and impartially discharge all duties incumbent on a convention
25	delegate, including the duty to abide by instructions established by joint
26	resolution of the General Assembly of Arkansas and to act only within the
27	scope of the General Assembly's application for the convention. I understand
28	that violation of this oath will result in my immediate recall and
29	replacement at the Article V Convention and that additional criminal
30	penalties may be imposed on me under Arkansas law."
31	(b) The General Assembly shall determine the instructions, if any, to
32	be given to the delegates, including without limitation instructions that:
33	(1) The delegates shall not support a voting rule other than the
34	rule whereby each state exercises one vote;
35	(2) On all voting matters and the Article V Convention, a simple
36	majority of the Arkaneas delegates shall constitute a single yote for the

1	State of Arkansas; and	
2	(3) The delegates shall not vote in the affirmative on an	
3	unauthorized amendment.	
4	(c) If a delegate votes or attempts to vote to allow consideration of,	
5	to consider, or to approve an unauthorized amendment for ratification to the	
6	United States Constitution, the:	
7	(1) Delegate is ineligible to serve as a delegate;	
8	(2) Delegate's certification under § 7-9-702(a) is revoked; and	
9	(3) Delegate shall be immediately replaced by an alternate	
10	delegate.	
11	(d) A vote cast or attempted to be cast by a delegate under subsection	
12	(c) of this section is null and void.	
13	(e) Upon the request of a delegate or alternate delegate, the General	
14	Assembly shall provide guidance to the delegate or alternate delegate	
15	concerning whether a proposed amendment is within the permitted subject	
16	matter of the Article V Convention.	
17	(f)(l) If a delegate knowingly violates the oath contained in this	
18	section, the delegate is guilty of usurping, overturning, or seizing	
19	government under § 5-51-204, a Class B felony.	
20	(2) A person convicted of a violation under subdivision $(f)(1)$	
21	of this section is barred from holding public office or state employment from	
22	the date of his or her conviction.	
23	(g)(l) The delegates shall elect from among the delegates a	
24	chairperson who shall serve until the election of a new chairperson by the	
25	delegation.	
26	(2) The chairperson will report to the General Assembly on all	
27	matters pertaining to the activities of the delegates and the Article V	
28	Convention.	
29	(3) The chairperson shall record all votes cast on proposed	
30	amendments by the Arkansas delegation.	
31	(h) Each delegate shall immediately notify the Delegate Advisory Group	
32	if he or she believes a delegate has violated his or her oath or instructions	
33	while participating in the Article V Convention.	
34		
35	7-9-704. Delegate Advisory Group.	
36	(a) Upon the ratification of a resolution calling for an Article V	

1	convention, the General Assembly shall appoint a "Delegate Advisory Group" to
2	recommend additional instructions to be given to delegates beyond those
3	articulated in the resolution.
4	(b) The Delegate Advisory Group shall consist of:
5	(1) The President Pro Tempore of the Senate, who shall serve as
6	chair of the group;
7	(2) One (1) member of the Senate elected by a simple majority;
8	(3) The Speaker of the House of Representatives;
9	(4) Three (3) members of the House of Representatives elected by
10	a simple majority;
11	(5) The Secretary of State; and
12	(6) One (1) citizen of the State of Arkansas, selected by the
13	President Pro Tempore of the Senate and the Speaker of the House of
14	Representative from a list of recommendations made by the Convention of
15	States Arkansas.
16	(c) Upon request of a delegate, the Delegate Advisory Group shall:
17	(1) Advise delegates if there is a reason to believe an action
18	or attempt to take an action would violate the instructions or limits placed
19	upon delegates; and
20	(2) Render an advisory determination within twenty-four (24)
21	hours of receiving such a request.
22	(d)(1) The Delegate Advisory Group shall advise the Attorney General
23	if there is reason to believe that a vote by the delegates has violated the
24	instructions or exceeded the limits of a delegates' authority.
25	(2) If the Attorney General declares the vote void and the
26	credentials of the commissioner are revoked, the Attorney General shall
27	determine if the actions of the delegate merit charges being filed against
28	the offending delegate in accordance with the legal penalties prescribed in
29	this subchapter.
