4 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

5 ARKANSAS STATE BOARD OF PUBLIC ACCOUNTANCY - PROMOTIONAL ITEMS. Upon
6 approval of the Chief Fiscal Officer of the State, the Arkansas State Board
7 of Public Accountancy is hereby authorized to transfer appropriation from
8 Operating Expenses to Promotional Items in the appropriation authorized by
9 the Arkansas State Board of Public Accountancy - Operations Appropriation in
10 this Act in an amount not to exceed five hundred dollars (\$500) each fiscal
11 year to meet the Board's educational needs.

12 The provisions of this section shall be in effect only from July 1, ~~2023~~
13 2024 through June 30, ~~2024~~ 2025.

15 SECTION 53. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
16 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

17 PROFESSIONAL BAIL BONDS COMPANY AND PROFESSIONAL BAIL BONDSMAN LICENSING
18 BOARD - FUND TRANSFER. The Professional Bail Bonds Company and Professional
19 Bail Bondsman Licensing Board shall deposit as special revenues sufficient
20 fees and penalties directly into the Bail Bondsman Board fund to provide for
21 personal services and operating expenses for the board. At the end of each
22 fiscal year, the Professional Bail Bondsman Licensing Board shall be allowed
23 to retain a fund balance sufficient to cover the personal services and
24 operating expenses of the board for the following fiscal year. Seventy-five
25 percent (75%) of any funds remaining in excess of this balance shall be
26 transferred to the General Revenue Fund Account in the State Treasury.

27 The provisions of this section shall be in effect only from July 1, ~~2023~~
28 2024 through June 30, ~~2024~~ 2025.

30 SECTION 54. SPECIAL LANGUAGE - CODE AMENDMENT. *Arkansas Code § 19-5-*
31 *1271(d)(2), concerning the obligation of the Arkansas Motor Vehicle*
32 *Commission to fund at the end of each fiscal year the amount necessary to*
33 *increase the Automotive Technologist Education Grant Fund balance to two*
34 *hundred fifty thousand dollars (\$250,000), is amended to read as follows:*

35 (2)(A) *Except as provided in subdivision (d)(2)(B) of this*
36 *section, shall at the end of each fiscal year in addition to its contribution*

1 under subsection (b) of this section fund the amount necessary to increase
2 the Automotive Technologist Education Grant Fund balance to two hundred fifty
3 thousand dollars (\$250,000).

4 (B) Funding provided by the commission under subdivision
5 (d)(2)(A) of this section shall not exceed the amount necessary for the
6 commission to retain three years of its running average ~~fund balance~~
7 operating expenses.

8
9 SECTION 55. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
10 authorized by this act shall be limited to the appropriation for such agency
11 and funds made available by law for the support of such appropriations; and
12 the restrictions of the State Procurement Law, the General Accounting and
13 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
14 Procedures and Restrictions Act, or their successors, and other fiscal
15 control laws of this State, where applicable, and regulations promulgated by
16 the Department of Finance and Administration, as authorized by law, shall be
17 strictly complied with in disbursement of said funds.

18
19 SECTION 56. LEGISLATIVE INTENT. It is the intent of the General
20 Assembly that any funds disbursed under the authority of the appropriations
21 contained in this act shall be in compliance with the stated reasons for
22 which this act was adopted, as evidenced by the Agency Requests, Executive
23 Recommendations and Legislative Recommendations contained in the budget
24 manuals prepared by the Department of Finance and Administration, letters, or
25 summarized oral testimony in the official minutes of the Arkansas Legislative
26 Council or Joint Budget Committee which relate to its passage and adoption.

27
28 SECTION 57. EMERGENCY CLAUSE. It is found and determined by the
29 General Assembly, that the Constitution of the State of Arkansas prohibits
30 the appropriation of funds for more than a one (1) year period; that the
31 effectiveness of this Act on July 1, 2024 is essential to the operation of
32 the agency for which the appropriations in this Act are provided, and that in
33 the event of an extension of the legislative session, the delay in the
34 effective date of this Act beyond July 1, 2024 could work irreparable harm
35 upon the proper administration and provision of essential governmental
36 programs. Therefore, an emergency is hereby declared to exist and this Act

1 being necessary for the immediate preservation of the public peace, health
2 and safety shall be in full force and effect from and after July 1, 2024.
