"(2)(A)(i) Every citation or deficiency cited to a provider shall refer by source and number to the authority upon which the citation or deficiency is based;

(ii) However, the requirement of subdivision (f)(2)(A)(i) does not limit the department and any entity with whom it contracts in the exercise and application of professional medical judgment in determining when and under what circumstances care is medically necessary."
