- SECTION 35. Affiliates of institutions of higher education.
- (a) Except as noted in this section, a non-profit corporation or other entity which is organized and exists for purposes described in Section 501(c)(3) of the Internal Revenue Code and which is an affiliate of a public institution of higher education, and any director, official, officer, or employee thereof or donor thereto, shall not be subject to the provisions of this act.
- (b) The affiliate shall furnish the public institution of higher education which it supports a copy of its annual audit prepared by a private independent certified public accountant or private independent public accountant.
- (c) Each public institution of higher education supported by an affiliate or affiliates shall file a copy of the annual audit of the affiliate or affiliates with the Legislative Auditor within thirty (30) days following receipt of the audit.
- (d)(1) If requested by the Legislative Auditor, the institution shall obtain from a supporting affiliate copies of specified accounts and records of the affiliate.
- (2) If determined necessary by the Legislative Auditor, the institution shall provide access to original accounts and records of the affiliate.
- (e)(1) All records, documents, correspondence, or other data that would infringe upon the rights or privacy or confidentiality of donors are exempt from public disclosure.
- (2) Any working papers or other data relating to donor information examined by the Legislative Auditor are confidential and shall not be released."
