## Amendment No. 2 to Senate Concurrent Resolution No. 34.

Amend Senate Concurrent Resolution No. 34 as engrossed, H4/14/03:

Delete the title and substitute the following:

"TO PROVIDE FOR AN EXTENSION OF THE REGULAR SESSION OF THE EIGHTY-FOURTH GENERAL ASSEMBLY UNTIL MAY 9, 2003, TO ENABLE IT TO COMPLETE THE ESSENTIAL BUSINESS OF THE SESSION; TO PROVIDE THAT THE GENERAL ASSEMBLY WILL RECESS ON APRIL 17, 2003; TO PROVIDE THAT THE EIGHTY-FOURTH GENERAL ASSEMBLY MAY BE CONVENED ON OR BEFORE MAY 9 TO CONSIDER VETOES, ERRORS, OMISSIONS, AND CONSTITUTIONAL AMENDMENTS."

AND

Delete the subtitle and substitute the following:
"EXTEND THE REGULAR SESSION UNTIL MAY 9, 2003, AND RECESS
ON APRIL 17."

AND

Page 2, delete lines 11 through 36

AND

Page 3, delete lines 1 through 36

AND

Page 4, delete lines 1 through 36

AND



Page 5, delete lines 1 through 14 and substitute the following:
"SECTION 1. The regular biennial session of the Eighty-Fourth General Assembly is extended until the close of business on Friday, May 9, 2003.

SECTION 2. The General Assembly shall enter into recess at the close of business on Thursday, April 17, 2003.

SECTION 3. The Speaker of the House of Representatives and the President Pro Tempore of the Senate may, by joint proclamation, reconvene the General Assembly at any time on or before May 9, 2003, for the purpose of considering vetoes, correcting errors, oversights, and omissions and completing its work on proposed constitutional amendments, including but not limited to any constitutional amendment or amendments dealing with public school finance which may be needed or required as a result of the Lake View case.

SECTION 4. If the General Assembly is reconvened on or before May 9, 2003, as authorized in Section 3, then upon completion of the tasks for which it was convened, it shall be adjourned sine die. If the General Assembly is not reconvened or adjourned on or before May 9, 2003, the Regular Session of the Eighty-Fourth General Assembly is adjourned sine die on that date."
